1 Introduction

1.1 Purpose of Statement of Commonality

1. This document provides the Examining Authority (ExA) with an overview of each Statement of Common Ground (SoCG) between the Applicant (Equinor New Energy Limited) and interested parties (see ExA's Rule 6 Letter [PD-006]) in relation to SEP and DEP at Deadline 6. This document will be updated and submitted at the requested deadlines outlined in the Examination timetable.



2 List of Statement of Commonality

2. **Table 1** provides the list of SoCGs that have been prepared by the Applicant in accordance with the list as requested by the Planning Inspectorate in Annex F of the **Rule 6 letter** [PD-006] issued on 13th December 2022.

2.1 Summary of Current Position of SoCGs

- 3. The SoCGs submitted alongside this document at Deadline 6 reflect the current position of the Applicant and stakeholders.
- 4. **Table 1** provides an overview of the status of each SoCG throughout the examination.

2.2 SoCGs not being submitted at Deadline 6

2.2.1 Anglian Water

5. Whilst a SoCG with Anglian Water has been submitted with all items shown as 'agreed', the document has not yet been signed [REP5-060]. Anglian Water would like to ensure that the full agreed protective provisions are translated into an updated DCO. A signed SoCG will be submitted at a later deadline.

2.2.2 Broadland District Council

6. Engagement between the Applicant and Broadland District Council is ongoing and it is anticipated that an updated SoCG will be submitted at D7.

2.2.3 East Suffolk Council

7. The Applicant and East Suffolk Council (ESC) have agreed not to submit a SoCG into Examination.

2.2.4 Eastern Inshore Fisheries and Conservation Authority (EIFCA)

8. Engagement between the Applicant and EIFCA is ongoing and an updated SoCG will be submitted prior to the end of Examination.

2.2.5 Environment Agency (EA)

9. Engagement regarding the Protective Provisions with the EA is ongoing. It is anticipated that an updated SoCG will be submitted at Deadline 7.

2.2.6 Historic England (Offshore and Onshore)

10. A combined draft SoCG for onshore and offshore matters is being prepared and will be submitted at Deadline 7.

2.2.7 Independent Oil and Gas

11. The Applicant and Independent Oil and Gas (IOG) may consider submitting a SoCG into Examination at a later stage should it be appropriate to do so.

2.2.8 Maritime and Coastguard Agency

12. Engagement between the Applicant and Maritime and Coastguard Agency is ongoing and an updated SoCG will be submitted prior to the end of Examination.

2.2.9 Ministry of Defence

13. Engagement between the Applicant and Ministry of Defence is ongoing and an updated SoCG will be submitted prior to the end of Examination.

2.2.10 National Air Traffic Services

14. The Applicant and National Air Traffic Services (NATS) have agreed not to submit a SoCG into Examination. The Applicant and NATS are in discussion regarding entering a Mitigation Services Contract.

2.2.11 National Highways

15. Engagement between the Applicant and National Highways is ongoing and it is anticipated that an updated SoCG will be submitted prior to the end of Examination.

2.2.12 National Trust

16. Engagement between the Applicant and National Trust is ongoing and an updated SoCG will be submitted prior to the end of Examination. As noted in response to Q3.14.1.6 in **The Applicant's Responses to the Examining Authority's Third Written Questions** [REP5-049], the Applicant was invited by the National Trust and Natural England to a meeting on 08 June 2023, to discuss an additional potential compensatory measure option involving rat eradication at Blakeney (i.e. within the North Norfolk Coast Special Protection Area), which has the support of both the National Trust and Natural England. Therefore, these proposals will be included in an updated version of the SoCG.

2.2.13 Natural England

17. A SoCG between the Applicant and Natural England will be submitted at the end of Examination

2.2.14 Norfolk County Council

18. Engagement between the Applicant and Norfolk County Council is ongoing and it is anticipated that an updated SoCG will be submitted prior to the end of Examination.

2.2.15 North Norfolk District Council

19. Engagement between the Applicant and North Norfolk District Council is ongoing and it is anticipated that an updated SoCG will be submitted at Deadline 7.

2.2.16 Norwich City Council

20. The Applicant and Norwich City Council have agreed not to submit a SoCG into Examination.

2.2.17 Norwich Airport

21. Engagement between the Applicant and Norwich Airport is ongoing and it is anticipated that an updated SoCG will be submitted prior to the end of Examination.

2.2.18 Norfolk Wildlife Trust

22. The Applicant and the Norfolk Wildlife Trust (NWT) submitted a SoCG at Deadline 4 [REP4-026]. Discussions are ongoing with respect to outstanding offshore matters (all onshore matters are agreed) and a final SoCG will be submitted prior to the end of Examination.

2.2.19 Perenco

23. Discussions are ongoing between the Applicant and Perenco with the intention to submit a SoCG at Deadline 7.

2.2.20 **REAF CIC**

24. The Applicant and REAF CIC may consider submitting a SoCG into Examination at a later stage should it be appropriate to do so.

2.2.21 Royal Society for the Protection of Birds

25. The RSPB has indicated to the Applicant that it is committed to delivering a SoCG however due to resource constraints within the RSPB there has not been time to fully review the extra material submitted since the DCO application. Therefore, the RSPB and the Applicant have agreed to submit a SoCG before the end of Examination.

2.2.22 South Norfolk Council

26. Engagement between the Applicant and South Norfolk Council is ongoing and it is anticipated that an updated SoCG will be submitted at Deadline 7.

2.2.23 Trinity House

27. Engagement between the Applicant and Norwich Airport is ongoing and it is anticipated that an updated SoCG will be submitted prior to the end of Examination.

2.2.24 UK Chamber of Shipping (UK CoS)

28. Engagement between the Applicant and UK CoS is ongoing and it is anticipated that an updated SoCG will be submitted prior to the end of Examination.

2.2.25 Statutory Undertakers

29. Protective provisions discussions are ongoing with a number of statutory undertakers and a SoCG with the following stakeholders is not considered necessary. The Applicant submitted an update to **The Statutory Undertakers Position Statement (Revision C)** [REP5-037] at Deadline 5 to update the ExA on the status of the negotiations taking place between the Applicant and statutory undertakers.

31. The Applicant and NFU have been in discussions surrounding a SoCG and a copy has been submitted at Deadline 5, with a minor correction submitted at Deadline 6.

2.3.2 Marine Management Organisation

32. Revision C of the **Draft SoCG with the MMO** [document reference 12.11] has been submitted at Deadline 6. For the majority of matters, final positions have been reached and the majority of these are agreed. There are a small number of matters which remain in discussion and which the Applicant anticipates being able to close out in a final SoCG at Deadline 8 following the submission of further clarifications by the Applicant at Deadline 7.


