## 1 Introduction

### 1.1 Background

1. The Sheringham Shoal Offshore Wind Farm Extension Project (hereafter SEP) and Dudgeon Offshore Wind Farm Extension Project (hereafter DEP) are proposed extensions to the existing Sheringham Shoal and Dudgeon Offshore Wind Farms (SOW and DOW). When operational, SEP and DEP would have the potential to generate renewable power for around 785,000 United Kingdom (UK) homes from up to 23 wind turbines at SEP and up to 30 wind turbines at DEP.
2. Equinor New Energy Limited (the Applicant) is submitting an application for a Development Consent Order (DCO) including a **Report to Inform Appropriate Assessment (RIAA)** (~~document reference 5.4APP-059~~), which provides the information necessary for the competent authority to undertake an Appropriate Assessment to determine if there is any adverse effect on integrity (AEol) on the national site network.
3. With respect to Sandwich tern from the North Norfolk Coast Special Protection Area (NNC SPA) and Greater Wash (GW) SPA, the Applicant's RIAA concludes that AEol cannot be ruled out as a result of predicted Sandwich tern mortality due to collision, and the combined effects of collision and operational phase displacement, when considered in-combination with other offshore wind farms (OWF). As such, the Applicant has presented a suite of documents as part of its consent application relating to the requirement for compensatory measures, including this Outline Sandwich Tern Compensation Implementation and Monitoring Plan (the outline Sandwich Tern CIMP).

### 1.2 Purpose of Document

4. The Sandwich Tern CIMP will be produced post-consent, as secured by Schedule 17 of the **Draft DCO (Revision J)** [document reference 3.1], and will set out the detailed delivery proposals for the agreed compensatory measures, based on those set out in **Appendix 2 Sandwich Tern Compensation Document (Revision B)** [document reference 5.5.2]. As described in the sections below, for each of the project-led measures to be implemented this will include details of the:
  - Scale and location;
  - Design;
  - Arrangements for monitoring, maintenance and adaptive management;
  - Reporting requirements;
  - Implementation and delivery programme; and
  - How the Sandwich Tern CIMP can be approved.
5. The purpose of this document is therefore to set out the outline of the Sandwich Tern CIMP, which will be developed in consultation with stakeholders through the Sandwich Tern Compensation Steering Group (STCSG) and submitted to the Secretary of State for approval in accordance with the DCO.

6. It should be noted that, as owners of SEP and DEP, Scira Extension Limited (SEL) and Dudgeon Extension Limited (DEL) are the named undertakers that have the benefit of the DCO. References throughout this document and any supporting annexes to obligations on, or commitments by, 'the Applicant' are given on behalf of SEL and DEL as the undertakers of SEP and DEP.

### 1.3 Consultation

7. This section will provide a summary of the consultation that has taken place through the STCSG in the development of the Sandwich Tern CIMP, including key decisions, agreements and outstanding issues under discussion. Where the latter exist, information will be provided on the proposed next steps to resolve any such matters. Proposals for future engagement will also be detailed, including how monitoring outcomes will be shared and actioned accordingly.
8. Specific topics of discussion for inclusion within the STCSG, and therefore the purpose of the group, will be regarding site selection, project / study design, monitoring, adaptive management options and associated triggers. The focus of the STCSG will be specifically to deliver the compensation for SEP and DEP.
