Dudgeon Offshore Wind Farm Extension Project (DEP)	The Dudgeon Offshore Wind Farm Extension onshore and offshore sites including all onshore and offshore infrastructure.
DEP onshore site	The Dudgeon Offshore Wind Farm Extension onshore area consisting of the DEP onshore substation site, onshore cable corridor, construction compounds, temporary working areas and onshore landfall area.

1 Explanatory Text

1. This CA Schedule includes all Category 1 Owners or Reputed Owners within the **Book of Reference (Revision FH)** [document reference 4.1] where acquisition of land and rights is required, and the Land Interest is able to provide proof of title. Where no interest has come forward declaring or proving ownership of unregistered plots, negotiations are not ongoing, and the plots have not been included in the CA Schedule.
2. Tenants, Lessees and Occupiers identified as Category 1 interests in the **Book of Reference (Revision HF)** [document reference 4.1] are not included in the CA Schedule as the Applicant is requesting such interests be signatories to voluntary agreements.
3. All Category 2 interests identified in the **Book of Reference (Revision HF)** [document reference 4.1] as having rights and/or apparatus within the Order Land are either protected within Owner or Reputed Owner voluntary agreements where applicable or are addressed within the **Statutory Undertaker's Position Statement (Revision E)** [document reference 12.46].~~[update of statutory undertaker negotiations]~~.
4. The Applicant is not seeking to acquire any rights within land owned by Category 3 interests identified in the Book of Reference as they are outside the Order Land. Category 3 interests therefore have been excluded from this CA Schedule.
5. Where a Land Interest is identified within the **Book of Reference (Revision FH)** [document reference 4.1] as having an interest in respect of subsoil beneath a public highway, such plots are excluded from this CA Schedule as the Applicant will obtain the required rights through the New Roads and Street Works Act 1991.
6. The stages of negotiation include Heads of Terms in respect of an Option Agreement where the in principle terms are agreed but at this point are not legally binding. Following signed Heads of Terms, legal advisors are instructed and the generic draft Option Agreement issued for further negotiation. Upon completion of negotiations of the Option Agreement, both parties can then exchange contracts. At this point, the Option Agreement becomes legally binding.
7. In all cases where Heads of Terms are agreed and respective legal advisors have been instructed, the Applicant is hopeful to conclude any relevant voluntary agreements by the close of examination. The Applicant will continue to progress with voluntary agreements after the Examination has concluded, and beyond the Secretary of State's decision on the DCO application should any not be signed by that stage.
8. The Applicant has amended the descriptions with the status key to more accurately reflect the Applicant's position through the different stages of negotiations.
9. This document has been updated and submitted at Deadline 5 to reflect the most up to date position on negotiations and was also updated at Deadline 3 to better distinguish between negotiations in relation to acquisition of rights, acquisition of freehold and those in respect of temporary possession.
