1. This is a joint statement between Equinor New Energy Limited (the Applicant) and Louise Anne Savory in relation to the Sheringham Shoal Offshore Wind Farm Extension Project (SEP) and Dudgeon Offshore Wind Farm Extension Project (DEP) Development Consent Order (DCO) application. It confirms the latest position in respect of the negotiation of a voluntary agreement between the Applicant and Louise Anne Savory and agreed timescales for its completion.

## 2 Matters that are Agreed

2. Heads of Terms setting out the basis of the voluntary agreement for land Weybourne Military Camp were issued to Louise Anne Savory on 30<sup>th</sup> May 2022.
3. A signed copy of the Heads of Terms was received on the 5<sup>th</sup> July 2022.
4. Louise Anne Savory's appointed legal representative is Birketts LLP who have been appointed by the Land Interest Group (LIG) to agree a draft option agreement on behalf of all landowners represented by LIG. Negotiations of this agreement remain ongoing, however there remain some areas of difference between the two parties. The Applicant will continue to engage with Birketts LLP in an endeavour to reach agreement with the draft option agreement so that it can be issued to Louise Anne Savory for consideration.
5. The Applicant and Louise Anne Savory acknowledge that the voluntary agreement will not be agreed prior to the close of Examination, however both parties hope that it will be possible to complete the agreement by 1<sup>st</sup> December 2023.

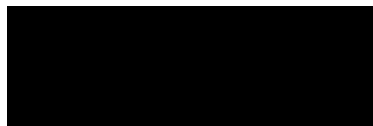
