Development Consent Order (DCO) application for Sheringham Shoal and Dudgeon Offshore Wind Farm Extension Projects (EN010109) – Examination Deadline 8 Document Submissions

1 **DEADLINE 8 SUBMISSIONS**

We refer to the Planning Inspectorate's Rule 8 Letter dated 30 May 2023 (the Rule 8 Letter). In accordance with the deadlines at Annex A of the Rule 8 Letter, Equinor New Energy Limited (the Applicant) encloses the documents listed in **Annex 1** of this letter in response to Deadline 8.

The Applicant highlights to the Examining Authority that the Examination Library was published on the Planning Inspectorate's website on 17 July 2023. The Applicant has therefore used its own document reference system to cross refer to its own Deadline 7 submissions (making clear the document revision referred to where necessary if different revisions of the same document (e.g. Draft DCO) have been made at Deadline 7 and Deadline 8) in its Deadline 8 submissions.

2 STATEMENTS OF COMMON GROUND

In the Planning Inspectorate's Rule 6 Letter dated 13 December 2022 (the Rule 6 Letter), Annex F requested that the Applicant submit Statements of Common Ground (SoCG) with a number of Interested Parties and Other Parties. A number of draft SoCGs and final SoCGs were submitted at previous deadlines. The Applicant now encloses the final SoCGs listed in **Annex 2** of this letter. **The Applicant's Statement of Commonality (Revision H)** [document reference 12.45] provides the final status of all SoCGs requested in Annex F of the Rule 6 Letter.

Please note there is a drafting error within some of the final SoCGs. Some of the final SoCGs make reference in the main body of the text to it being a 'draft SoCG', however, the Applicant can confirm that the revisions submitted at this deadline are the final signed SoCGs. The Applicant has not amended the drafting error because the revisions submitted at this deadline have been agreed and signed by stakeholders.

3 ADDITIONAL SUBMISSIONS

The Applicant encloses a number of additional submissions being made at Deadline 8. These are new documents, or updates to previously submitted documents where the Applicant considers that these provide information, clarifications and updates useful to both the Examining Authority and Interested Parties. **Annex 3** of this letter contains a list of additional documents that have been submitted by the Applicant.

4 OTHER MATTERS

4.1 RULE 17 LETTER (DATED 12 JULY 2023)

The Applicant notes that a Request for Further Information was published by the Examining Authority pursuant to Rule 17 of The Infrastructure Planning (Examination Procedure) Rules 2010 on 12 July 2013 (the Rule 17 letter). The Applicant has provided responses to the Rule 17 letter in **The Applicant's Response to the Examining Authority's Rule 17 Letter dated 12 July 2023** [document reference 22.2].

With regards to the questions within the Rule 17 letter that have been prompted by the Secretary of State's decision of 12 July 2023 to grant development consent for The Hornsea Four Offshore Wind Farm Order (EN010098) (Hornsea Project Four), the Applicant appreciates that the Examining Authority will be keen to understand what the implications of that decision are for their assessment of SEP and DEP.

However, the Applicant has simply not had sufficient time before the close of this Examination to fully review the decision (including the Habitats Regulations Assessment and recommendation report) and understand all of the implications for SEP and DEP. Furthermore, the Applicant has had to consider this decision whilst also ensuring it meets the other procedural deadlines fixed for Deadline 8.

The Applicant has sought to be as helpful as possible in responding to the questions raised by the Examining Authority in the Rule 17 letter. However, the Applicant considers that there may be aspects of the Hornsea Four decision that are material to SEP and DEP that have not been identified, given the time limitations. The Applicant considers that it may be necessary and appropriate to prepare a more detailed response in due course to be submitted to the Secretary of State and would reserve its position on doing so.

4.2 CLOSING STATEMENT

The Applicant encloses at Deadline 8 The **Applicant's Closing Statement** [document reference 22.11] to provide the Examining Authority with the Applicant's closing view on why it respectfully considers the Examining Authority can recommend SEP and DEP be granted consent. The document aims to draw together various strands of information that have been to provided through the course of the examination, and to provide a clear summary of the Applicant's final position on key matters outstanding with Interested Parties.

4.3 JOINT RESPONSE FROM THE APPLICANT AND NATURAL ENGLAND IN RELATION TO HRA CONCLUSIONS AND DEROGATION REQUIREMENTS

The Examining Authority's Second Written Question Q2.14.1.1 [PD-012] requested a joint response from the Applicant and Natural England in relation to HRA conclusions and derogation requirements which was provided within Appendix B.2 of Appendix B - Supporting documents to the Applicant's Responses to the Examining Authority's Second Written Questions [REP3-103] submitted at Deadline 3. This was subsequently updated at Deadline 7 (see Supporting Documents for the Applicant's Responses to the Examining Authority's Fourth Written Questions [document reference 21.5.1]). Throughout its Deadline 7 submissions, the Applicant noted that this document would be updated and resubmitted at Deadline 8; however, it has instead been combined with the relevant Natural England SoCGs i.e. Final Statement of Common Ground with Natural England (Offshore) (Revision B) [document reference 14.7], Final Statement of Common Ground with Natural England (Offshore Ornithology) (Revision B) [document
