1 GUIDE TO THE APPLICATION

1.1 Introduction

- 1. Equinor New Energy Limited (the Applicant) is applying to the Secretary of State under the Planning Act 2008 on behalf of Scira Extension Limited and Dudgeon Extension Limited for powers to construct, operate and decommission the Sheringham Shoal Offshore Wind Farm Extension Project (SEP) and Dudgeon Offshore Wind Farm Extension Project (DEP). This document provides a guide to the Applicant's Development Consent Order (DCO) application (the 'Application') for SEP and DEP.
- 2. This is a live document and will be updated when updates or revisions to existing documents are made and when new documents are submitted to the Planning Inspectorate.
