The Sheringham Shoal and Dudgeon Extensions Offshore Wind Farm Order 2024 – Proposed Non-Material Change Application Regulation 7(3) – Request for Approval of the Consultee List

Background

- Equinor New Energy Limited, on behalf of Scira Extension Limited (SEL) and Dudgeon Extension Limited (DEL), submitted an application for development consent for the Sheringham Shoal Offshore Wind Farm Extension Project (SEP) and Dudgeon Offshore Wind Farm Extension Project (DEP) on 02 September 2022.
- 2. On 17 April 2024 the Secretary of State for the Department for Energy Security and Net Zero (DESNZ) granted the Sheringham Shoal and Dudgeon Extensions Offshore Wind Farm Order 2024 (the as made Order) for the development of an offshore wind turbine generating station(s) (i.e., SEP and / or DEP) with a gross electrical output capacity of more than 100 megawatts. The Order grants consent for SEP and DEP to be constructed, maintained and decommissioned under any of scenarios 1(a), 1(b), 1(c), 1(d), 2, 3, or 4, as defined in the as made Order.
- 3. The SEP and DEP wind farm sites are located approximately 15.8 and 26.5 km respectively from the North Norfolk coast. SEP and DEP will be connected to shore by offshore export cables installed to the landfall at Weybourne on the North Norfolk coast. From there, the onshore export cables travel approximately 60 km inland to a new high voltage alternating current (HVAC) onshore substation near to the existing Norwich Main substation.

Non-Material Change Application

4. SEL and DEL are intending to apply for a non-material change (NMC) to the as made Order in relation to the offshore works of the projects.



- 5. SEL and DEL have been in discussion with The Crown Estate with respect to the potential for an increase in the generating capacity of the projects, to be delivered within the existing areas of seabed as defined within the agreements for lease with The Crown Estate and within the Order Limits of the as made Order.
- 6. The proposed NMC application is intended to allow for this increase to the maximum generation capacity of SEP and DEP.
- 7. To realise the increase in generating capacity there is a need to amend design envelope parameters with respect to:
 - An increase to the wind turbine rotor swept area (from 1.00 km² to up to 1.42km² for SEP and from 1.30 km² to up to 1.85 km² for DEP) and the subsequent requirement for a potential increase in the minimum air gap between the lowest point of the rotating blade of the wind turbine generator and highest astronomical tide to ensure ornithology collision risk effects are no greater than those assessed as part of the Development Consent Order (DCO) application;
 - An increase in the maximum number of interlink cables from seven to eight in the event one
 Offshore Substation Platform (OSP) is constructed for SEP and DEP (in the SEP wind farm site,
 Scenario 4 in the DCO) and from three to four in the event two OSPs are constructed (Scenarios
 1(c), 1(d), 2 or 3 in the DCO) or in the case that only DEP is constructed (scenario 1(b) in the
 DCO); and
 - Increases to the maximum area and volume of external cable protection and to the maximum number of cable crossings for scenarios 1(b), 1(c), 1(d), 2, 3, and 4, associated with the increased maximum number of interlink cables.
- 8. It should be noted that the upper limits of the wind turbine design envelope with respect to the number of wind turbines, rotor diameter and blade tip height will not be amended by the NMC application.
- 9. No amendments to the upper limits of the foundation parameters (e.g., pile diameter, hammer energy) will be sought in the NMC application. In addition, the application will not seek any changes to the onshore elements of SEP and DEP. There is no requirement for additional land, nor for any change to the Order Limits. Furthermore, there is no requirement for any change to the Works Plans (Offshore) (Revision D) [document reference 2.7] or the Works Plans (Onshore) (Revision D) [document reference 2.6].
- 10. A parallel application to the Marine Management Organisation (MMO) will also be made to vary the associated Deemed Marine Licences (DML) in accordance with the changes sought in the NMC application.

Consultation

- 11. In accordance with Regulation 7(3) of the Infrastructure Planning (Changes to, and Revocation of, Development Consent Orders) Regulations 2011, SEL and DEL are seeking the consent of the Secretary of State for a focused and targeted consultation for the proposed NMC application as the proposed amendments only affect the offshore works.
- 12. In identifying the consultee list, consideration has been given to those stakeholders who reserve an interest in the offshore environment alongside infrastructure asset owners and other users of the sea who are considered to have a clear interest in the nature of the proposed change.
- 13. Details of the consultees that are proposed to be consulted with on the NMC application are provided in Appendix 1 to this letter. Appendix 2 lists those stakeholders that the Projects do not intend to consult with and sets out the Projects' reasons for excluding them.



- 14. In addition, formal public consultation will be undertaken, with a notice of the NMC application being published in accordance with Regulation 6 of the Infrastructure Planning Regulations 2011. This notice will be published for two consecutive weeks in the following publications:
 - Eastern Daily Press
 - North Norfolk News
- 15. We would be grateful if you can confirm approval of the consultee list provided in Appendix 1 and that the publication proposals as outlined above are acceptable. SEL and DEL intend to submit the NMC application as soon as possible.
