On the first point on the need to transport several loads of waste to the site every day, there is clearly not enough waste generated locally to need to meet the needs of the site in Wisbech.

Now this scheme is coming through you for to you for decision rather than local planning authorities on the premise that you should both vitally need it for waste burning and will deliver sufficient electricity into the national grid to make nationally strategic infrastructure.

Public authorities like ours and the county councils, all with published ambitious targets to reduce waste and increase recycling, making demand for residual waste burning intuitively decrease nor increase over the coming years.

Need impact on environmental green initiatives at a national level and power generation.

We have problems with air pollution regularly as it is where we have, we have dust and we have sand from the Sahara. This happens very often in the in the spring and it has caused a lot of issues. We already have pollution from agricultural and from industrial areas locally and also across from the river in Germany. So we are a concentration already of great concern that there should be something else which could put particulate matter out into the air.

We experienced a great problem ten years ago when another firm tried to build an incinerator very close to the town and for five years the community became more and more aware. And finally the county council voted not to be in the contract with this incinerator firm for planning, solely voted against it, and voted to have a no incinerator Norfolk policy. And last May, the County Council also voted to object in principle to this incinerator on the Norfolk border because we also have a no incinerator policy we brought in 2015 and we feel it's wrong that something should be so close.

And the reasons, having done a lot of research on this matter. So the problem is that we know that incinerators tend to be built in areas of poverty and deprivation, and the health effects from these

There are clearly other businesses in London offering the same services as they choose to use our business in Wisbech over 2 hours away, which we are immensely proud of. The lorries drive from London on a regular basis to collect the goods we've manufactured.

But I feel very personal, angered by all this, because having a family that's lived here for 500 years in business and everything else in my life that this is taking place, it's an it's a nightmare, an absolute nightmare. The questions I'm listening to today, Mr. Booth, who acted on behalf of Mr. Carey. One of the questions was asked to him, Why did you put it in Wisbech? He said because there was a greater need for energy in Wisbech What greater need for you? What four more light bulbs is not great and he's going to pump more electric into the grid systems and the byproduct is steam.

Now that the big companies here, Perine, have already said they don't want it. So as fun westerns, all the big factories don't want the steam.

This is just a byproduct of what they're doing. We got our power station eight miles down the road on the river. Nene, that's derelict. It sits there empty because they went bust. And this will be another one of them because so many years down the road, it'll be a big block on the landing and they won't even be producing nothing. So this is a big choice for the government to make.

That residual waste is left over after everyone's done their recycling and to turn it into useful energy. Be that in the form of electricity or heat. Now, you may not believe this, but Wisbech is in a region where there is a shortage of energy recovery capacity and too much waste go into landfill.

And that is a matter of fact that we will demonstrate and be able to demonstrate in our documents. And this site is, despite what you might feel an ideal site for the use, the useful use of this energy that we would create. Some of it will go into the national grid, of course. Yes, it will. But electricity can be used locally, as can the heat. And and that's something we've also proven to good effect in Plymouth.

I do find it a little ironic that Norfolk County Council, despite having a no incineration policy, manages to send its waste to an energy from waste facility some hundred or so miles away in Bedfordshire. ironic that that is the case. And Cambridgeshire sends its waste basically to landfill. Again, government policy at the highest level supports the removal of waste away from landfill and what's screwed up the hierarchy to energy recovery. Good evening. I'm Rena Black. I'm a resident in King's Lynn and Wisbech area and I would first like to say I oppose this incinerator being built and any proposal in the future in this area. So there is little hope that one finds when thinking about the enormity of the climate crisis as a sense of the problem is much larger than one person can solve. Larger than yourself. Larger than your family. But where we cannot protect the entire world and fight every battle we can defend our own corners of the world.

And that is what we are doing here today. And I hope that you will hear us. So to put it plainly, incinerators actually produce recycling. A lot of what has already been said tonight, but I'm just going to quickly go over it. So this plant promises is to have the capacity to burn 625 600 tons of waste per annum. I'm sorry, but where is that waste going to come from? There is no capacity on the roads for this waste. Secondly, studies indicate that most of what is currently in the residual waste stream is relatively recyclable material, meaning a significant portion of what is currently incinerated could have actually been recycled and posted.

A report published in August 2020 say that a total of residual waste from household sources in England, estimated at 53%, could have actually been recycled. This is unbelievable. If incinerates is limited their feedback stock to generally residual waste and it would free up more than half of what is their current capacity undermining the rationale for this incinerator to be built in Wisbech.

The government has a target for England to achieve 65% of recycling for municipal solid waste by 2035 and no more than 10% landfill as some residual residual waste is not compostable, composable or combustible. The government's 65% recycling target implies that the rate of incineration should be no higher than a maximum of 30% in the UK. However, in 2020 it sat at 45.5%. Incineration is already at overcapacity.

In the UK, there is absolutely no need for this incinerator to be built. Other than profits for this company at the expense of us.

The argument that burning waste can be used to recover energy makes very good greenwash sales promotion for companies like this. Unfortunately, the reality is that saving energy and creating energy really was the goal. The more energy can be saved by society in actually reusing objects and recycling materials than can actually be recovered from burning anything. It's important to note the fossil carbon intensity of electricity exported from incinerators on the grid has been found to be 49% higher than predicted.

Of the plants studied in 2020, the UK is 55. Generators released a combined total of 40 million tonnes of CO2 and around 6.4 million tonnes of which of which were from fossil fuel services such as plastic. The 6.4 million tonnes actually cost the UK 1.5 billion in money from their taxpayers to clean up the waste generated by these plants.

Over half the capital cost of an incinerator build. And by the way, this one has a price tag of 300 million.

But today it goes into air pollution control equipment. Ironically, if this waste were not burned in the first place and properly recycled, the tremendously expensive equipment would not be necessary, nor with the toxic ash collectors. And these devices have been sent to an expensive hazardous waste landfill because, by the way, it still goes to landfill. You do not solve the landfill problem with incinerators, nor would the air emissions be subjected to very costly monitoring.

In addition to the greenhouse emissions that will further exacerbate the climate crisis. Incinerators emit many toxins and pollutants that have been said here today. If this plant goes ahead, you are looking at a room full of cancer patients in the future. And that is the plain truth. I don't care how good they say that their monitoring is and how much they have to look at pipes for these particles. Unfortunately, the better the air filtration systems in incinerators, more can be said that the finer the particles, the higher concentration of toxic metals is produced.

That means that these toxic metal metals are 100 times more toxic than their counterparts that are tested for. And these are released into the atmosphere, into the surrounding areas that go into the cell membranes of the people in these communities. I do not wish to be subjected to this.
