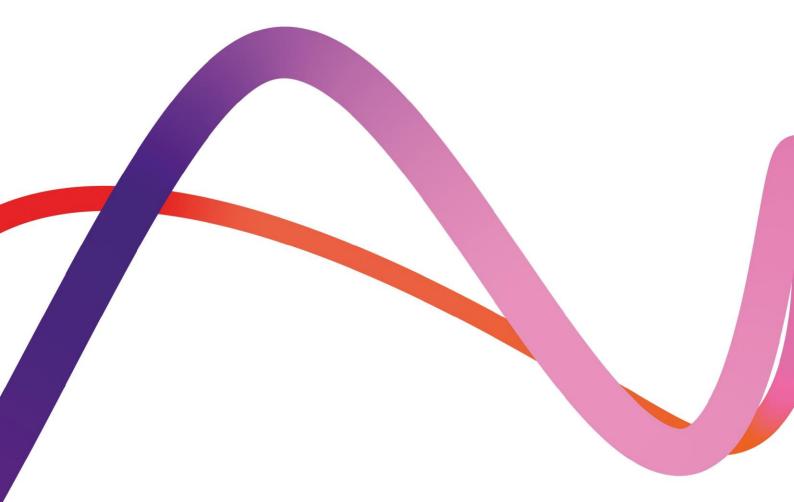

1. Introduction

1.1 Purpose of the Document

- This document sets out the Applicant's proposed itinerary for the Accompanied Site Inspection (ASI), taking account of the suggestions made from Interested Parties (IPs) at the Procedural Decision A deadline (9 February 2023).
- This document is requested by the Examining Authority (ExA) for Deadline 1 (10 March 2023) as per the examination timetable published on 2 March 2023.



2. Proposed Locations

2.1 Scope of the ASI

- The examination timetable published on 2 March 2023 confirms that an ASI will be held on Thursday 11 May 2023 (a single day).
- The Rule 6 letter **[PD-005]** confirms that the ASIs are only necessary to view land to which there is no public right of access, or with no clear view from nearby locations with open public access.
- The purpose of ASIs is familiarisation only and no discussion of the merits of the Proposed Development will be entertained during an ASI.
- The Rule 6 letter **[PD-005]** confirms that the ExA may hold further unaccompanied site visits (USI), in addition to the USI carried out on Wednesday 23 November 2022 **[EV-001].**

2.2 Proposed ASI Locations

- The Applicant submitted a list of suggested locations for both ASI and USI in its response to Procedural Decision A on 9 February 2023 (Table 1 and Figure 1 [PDA-001]).
- The locations proposed for the ASI by the Applicant where the location is not accessible by public land are:
 - Location 4: Algores Way Transfer Station; and
 - Location 11: Walsoken substation.
- Suggestions for ASI locations were also received from the following Interested Parties at Procedural Decision A:
 - Cambridgeshire County Council (CCC) [PDA-007];
 - Norfolk County Council (NCC) [PDA-009]; and
 - Virginia Bucknor [PDA-010].
- The Applicant has reviewed the suggested ASI locations from the Interested Parties. **Table 2.1** below sets out these proposed locations and the Applicant's view on whether these should be incorporated into the draft ASI Itinerary.
- 2.2.5 It should be noted that these only include the locations suggested for the ASI; CCC provides additional suggestions for USI locations for consideration by the ExA in its response [PDA-007].

The Applicant's Environmental Impact Assessment has not identified any likely significant effects on the users of the sports pitches at the TCA, for example ES Chapter 9 Landscape and Visual (Volume 6.2) [APP-036]. This could be demonstrated via a site visit, subject to the agreement of the Thomas Clarkson Academy. The Applicant has contacted the management trust to understand if access can be secured and will report back at Deadline 2. In the event access cannot be secured, the TCA could be viewed from Weasenham Lane.
CCC [PDA- 007]	The Helping Hands Disability Group	To fully appreciate the impact that the Proposed Development would have on each of the facilities and how it would dominate the skyline.	No – recommend conducting as USI. The Applicant considers that in order to understand the potential effects at this location it would be reasonable for the ExA to carry out an USI on public land on Algores Way adjacent to the Helping Hands Disability Group.

No – recommend conducting as USI. The Applicant considers that in order to understand the potential effects at this location it would be reasonable for the ExA to carry out an USI on public land adjacent to 2 Algores Way.

It should be noted that 9 New Bridge Lane is owned by the Applicant, (see Book of Reference (Volume 4.1) [AS-006]). 10 New Bridge Lane is already included as Location 6 in the Applicant's suggested site visit locations [PDA-001].

			Although the Applicant does not consider it necessary to obtain access onto private land associated with these properties, and considers that the ASI could be conducted at these locations safely from New Bridge Lane, the Applicant does agree that these locations should be included in the ASI.
CCC [PDA- 007]	Residential property No. 25 Cromwell Road	To fully appreciate the proximity and arrangement of these two residential properties to the Proposed Development.	To be confirmed 25 Cromwell Road appears to be an industrial unit. Therefore, the Applicant has sought clarification and awaiting a response from Cambridgeshire Council.
NCC [PDA- 009]	Grid Connection to the Walsoken DNO Substation from Broadend Road.	To visit locations of the Proposed Development that would occur in Norfolk County.	Yes – included in draft ASI itinerary. This location is already included as Location 11 in the Applicant's suggested site visit locations (Table 1 and Figure 1 of [PDA-001]).

Virginia Buckno r [PDA- 010]	A1101 from Freedom Bridge in Wisbech (by the Boathouse)	waste from a wide radius of the country into	The Applicant is not proposing to transport waste through the centre of Wisbech. Figure 2.1 of the Outline Operational Traffic Management Plan (Volume 7.15) [APP-106] illustrates the routing restrictions that would be in place for waste deliveries. This shows that waste would be delivered to the site from the A47 – Cromwell Road – New Bridge Lane junctions. The Operational Traffic Management Plan is secured in Requirement 12 of the Draft DCO (Volume 3.1) [APP-013].



2.3 Draft ASI Itinerary

On the basis of the ASI locations suggested by both the Applicant and Interested Parties, and taking into account the need to visit all locations in one day, the proposed Itinerary for the ASI is set out in **Table 2.2** below.
