Response to Deadline 4 (Thursday 25 May 2023)

This letter sets out Medworth CHP Limited's ('the Applicant') response to the Examining Authority's (ExA) request for submissions at Deadline 4, as set out in the Rule 8 letter issued by the ExA on 2nd March 2023.

Submitted Documents

Table 1.1 (enclosed) lists the documents submitted by the Applicant at Deadline 4, including those requested by the ExA within their Rule 8 letter and additional supporting documents. The reason for each document submitted is explained in Table 1.1.

Where appropriate, track-changed versions of existing documents are submitted to provide an understanding of the precise changes made.

Statements of Common Ground

Statements of common ground with the Environment Agency (Volume 9.7) and Natural England (Volume 9.9) have been concluded and final signed versions have now been submitted at Deadline 4.

The Applicant has continued to engage with the Host Authorities to progress the draft SoCG first submitted at Deadline 1 (Volume 9.4) [REP1-038]. An updated SoCG, incorporating the authorities' comments on Revision 1, was shared on 28 April 2023.

Cambridgeshire County Council and Fenland District Council responded on 19 May 2023 and Norfolk County Council and the Borough Council of King's Lynn and West Norfolk intend to provide comments shortly. The Applicant is seeking to meet with the Host Authorities to enable an updated SoCG to be submitted for Deadline 5 on Friday 16 June 2023.

The Applicant has continued to engage with Wisbech Town Council with a view to updating the SoCG (Volume 9.6) [REP1-040] for Deadline 4. However, Wisbech Town Council wishes to await receipt of the updated Waste Fuel Availability Assessment (WFAA) (Volume 7.3), that the Applicant is providing at Deadline 5 on 16 June 2023, before commenting and agreeing an updated SoCG. The Applicant will therefore seek to provide an updated SoCG at Deadline 6 on 12 July 2023, once Wisbech Town Council has had the opportunity to consider matters further.

An updated SoCG (Volume 9.5) has been shared with Walsoken Parish Council for comment on 17 May 2023 and the Applicant is seeking a meeting to finalise matters in time to submit an updated, and potentially final, version at Deadline 5 on 16 June 2023.

The Applicant is continuing to discuss the matter of potable water supply with Anglian Water and the SoCG (Volume 9.10). Meetings have been held and further information provided to Anglian Water. The Applicant is confident that it will be able to reach common ground during the Examination with Anglian Water and it is intended that a version of the draft SoCG will be submitted at Deadline 5 in accordance with the Examining Authority's Rule 8 letter or for Deadline 6.

With regard to Hundred of Wisbech (Volume 9.13) and KLIDB (Volume 9.14) updated SoCGs were submitted on 7 May 2023. Further meetings are being arranged and it is intended that a version of the draft SOCG will be submitted at Deadline 5 in accordance with the Examining Authority's Rule 8 letter or at Deadline 6.

Discussions with National Highways (Volume 9.15) and Network Rail (Volume 8.2) continue and it is intended that an updated version of the draft SOCGs will be submitted at Deadline 5 in accordance with the Examining Authority's Rule 8 letter or for Deadline 6.

Applicant's written summary of oral submissions

The Applicant's written summary of oral submissions at the ISH3 - 5 on environmental matters held on Tuesday 16 – Thursday 18 May 2023 (Volumes 12.2a, 12.2b and 12.2c) includes the Applicant's response to the action points made at the hearings.

Applicant's responses to action points arising from the Compulsory Acquisition Hearings 1 and $2\,$

The Applicant's responses to action points from the Compulsory Acquisition Hearings 1 and 2 held on 13 April 2023 are provided in Volume 12.5 (CAH1 action point 4), and Volume 12.7 (CAH2 action point 7). Due to technical issues, the Applicant's response to CAH2 action point 6 will be submitted at Deadline 5.

Environmental Permit Update

The Environment Agency duly made the Applicant's Environmental Permit application on the 23 March 2023. Written notification of the consultation arrangements (if required) and determination process are due to be issued by the Environment Agency.

The Applicant will continue to engage with the Environment Agency and to update the ExA on the progress of the application during the course of the DCO examination.
