Cover Letter – Submission of Documents Pursuant to the Change Application

INTRODUCTION

Purpose of this Report

We write on behalf of Medworth CHP Limited (the Applicant) with reference to the Change Notification Letter submitted by the Applicant on 18 May 2023 (the Applicant’s Letter).

The Examining Authority (ExA) issued a procedural decision in respect of the Applicant’s Letter on 26 May 2023 (the ExA’s Letter).

The Applicant has met with Cambridgeshire County Council (CCC) to confirm the legal status of the additional land to be included with this Change Application. As a result of those discussions, it has been confirmed that all of the additional areas of land are adopted public highway, with the exception of a small area of land which, while identified as being currently located outside of the adopted public highway, is to be dedicated as public highway pursuant to a section 104 agreement between CCC and Tesco Stores Limited.

The Applicant has through its discussions with CCC confirmed that all necessary works can be undertaken using temporary possession powers pursuant to Article 32 of the Draft Development Consent Order (DCO) and/or the powers in Article 11 of the draft DCO and that this does not engage the Infrastructure Planning (Compulsory Acquisition) Regulations 2010. The Applicant has provided further

information on this matter within the Change Application Report section 2.4.

The Applicant is now formally submitting the Change Application alongside the updated Application Documents. Table 1.1 lists the documents that are enclosed with this submission.

For clarity each document that has been provided in respect of the Change Application has included 'Change Application' within the title. The Application Guide has been updated to reflect the latest status and list of documents submitted as part of the Change Application.

The Land Plan and Works Plan have been updated to show the revised Order Limits and changes to works and access requirements and plots and rights sought arising from the Change Application.

The Draft DCO has been updated to account for changes to the plans associated with the Change Application. An updated Explanatory Memorandum is not submitted alongside this Change Application as no changes are required to it as a result of the changes proposed.

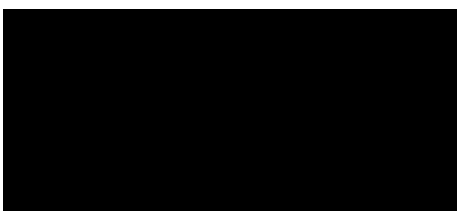
The Applicant has not included within the Draft DCO a provision authorising the compulsory acquisition of the additional land (as defined in the Infrastructure Planning (Compulsory Acquisitions) Regulations 2010 (the CA Regulations 2010)). Updates to the Statement of Reasons and Book of Reference have been included as part of the Change Application to reflect one small area of land that will be subject to temporary possession powers only. No updates are required to the Funding Statement as the changes do not impact the applicability of this document.

No update is submitted to the Other Consents and Licences document [APP-026] as no changes are required as a result of the Change Application.

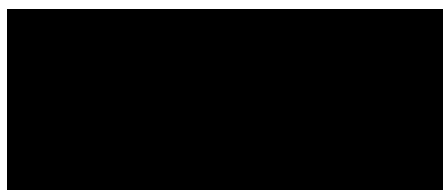
The Change Application Report provides information to support the request for the ExA to consider the Change Application and accept the change into the Examination process for the Application.
