I wish to voice my grave concerns over this proposal. Its siting would be injurious to the health and well-being of the population of Wisbech and it would sound a death knell on the town with a completely negative impact. Much has already been written about the hazards to health (physical and mental) due to the pollution (noise and environmental) caused by the constant road congestion 7 days a week etc. Far better would be to consider this area for serious levelling up in an effort to relieve the pressure of traffic congestion in Cambridge. Investment in reviving the rail link between Wisbech and Cambridge would be a means of connecting these two Cambridgeshire points, offering those who work in Cambridge and who cannot afford Cambridge property and rental costs an alternative option within commuting distance. Reducing the pressure on Cambridge could then make the scheme for expansion more workable and realistic. And just further on 'levelling up', a rail link and investment in building, renovating existing properties so that they are fit for intergenerational housing etc would regenerate an area long neglected. Wisbech, as is well known, has the greatest concentration of listed Georgian buildings in the country alongside a most fantastic history.

This area has being a Tory stronghold with its history, architecture and cultural landmarks and to consign it to the environmental abyss would be a betrayal in every sense to its population.
