**Application by Medworth CHP Limited for an Order Granting Development Consent
for Medworth Energy from Waste Combined Heat and Power Facility**

Notice of the decision by the Secretary of State

I write to notify you of the re-instatement of the Secretary of State's decision and statement of reasons and the Order granting development consent in relation to the above application.

Following publication of the announcement and documents relating to the Medworth Energy from Waste Facility DCO on 20 February 2024, clarification was required. Whilst that clarification process took place, information relating to the decision was removed from the Planning Inspectorate's website.

We understand the importance of clarity in relation to planning decisions and have worked urgently to reinstate the documents. The announcement and relevant documentation have now been reinstated on the Planning Inspectorate's website, with no alterations having been made.

The Secretary of State as the decision maker under s103 and s104 of the Planning Act 2008 (PA2008) has decided that development consent should be granted and therefore has made an Order under s114(1)(a) of PA2008.

There is no right of appeal under the PA2008. The High Court may entertain proceedings to question an Order granting development consent from the day on which the Development Consent Order is published or, if later, the day on which the decision letter is published. The procedure is to make an application for judicial review. This must be done within the statutory period of time set out in s118 of PA2008.
