**THE MEDWORTH ENERGY FROM WASTE COMBINED HEAT AND POWER ORDER 2024
REFERENCE: EN010110 – REQUEST FOR CORRECTION ORDER**

We act for Medworth CHP Limited.

Further to the Secretary of State's decision to make the above Order on 20 February 2024, we have reviewed the form of the Order as made. In doing so, we have identified a number of correctable errors within the Order.

This letter and its enclosures therefore constitute a written request on behalf of Medworth CHP Limited to correct these errors, pursuant to paragraph 1(5)(a) of Schedule 4 to the Planning Act 2008.
