# 1 Applicant's Update on the Marine Licence Submission and Progress

- 1 As forewarned in the Deadline 1 update on the Marine Licence (REP1-014), the Applicant and Natural Resources Wales Marine Licensing Team (MLT) met on 26 October 2022, further to discuss timescales for, and alignment of, responses to:
  - ▲ The Examining Authority's (ExA's) written questions (published on 27 September 2022 and responded to in submissions made at Deadline 1 on 24 October 2022); and
  - ▲ MLT's request for further information (published on 8 September 2022 with no deadline for response).
- 2 In advance of the meeting, the Applicant provided MLT with a matrix showing overlaps between Deadline 1 submissions and MLT's request for further information, plus suggested next steps.
- 3 At the meeting, a deadline of 25 November 2022 was agreed for the Applicant to submit:
  - ▲ All Deadline 1 submissions with relevance to the Marine Licencing process (as set out in the matrix);
  - ▲ Detailed response to representations submitted to the Marine Licence consultation process (cross-referenced to the above); and
  - ▲ Detailed answers to MLT's request for further information where not answered by the above two submissions.
- 4 This deadline was agreed in support of alignment of materials submitted to the two consenting processes around Deadline 3 (on 23 November 2022).
- 5 MLT will review the materials to be submitted on 25 November 2022 and consider the need for further consultation and/or questions. MLT and the Applicant have agreed further meetings on: 17 November 2022, to discuss any matters arising from Deadline 2 submissions; and 2 December 2022, to discuss the detailed submissions listed above and next steps.
