The only designated historic asset within 3km of the marine licensable area is the Historic Wreck DW5 Resurgam, which will not be affected by the proposed works. There are a number of undesignated historic assets inside and in the vicinity of the proposed works which could be affected by them. It is recommended that the Marine Investigator at the Royal Commission on the Ancient and Historic Monuments in Wales should be contacted for advice on the impact of the proposed works on them.

The scheduled monument and listed buildings identified attached are located inside 3km of the landfall of the proposed connection for the windfarm: However, any impact on their settings will only occur during the construction phase of the development and this will not be significant.
