Please confirm whether you are of the same view and provide detailed reasons should you consider otherwise.	<p>The parties continue to work together towards an agreed form of protective provisions.</p> <p>The key outstanding issue to be agreed is the safeguarding of an area within the Order Limits for the future extension of the Bodelwyddan substation and associated works and infrastructure (including new overhead line gantries and the diversion of an existing gas pipeline to facilitate the substation extension). These upgrading works are critical to enable the connection of multiple projects at this location (the Awel Y Mor Project being only one of a number of projects requiring a future connection to the Bodelwyddan substation).</p> <p>NGET anticipates that appropriate agreement should be reached before the end of the Examination. An update will be provided to the Examination in due course.</p>
