1 Landscape Enhancement Package

1.1 Progress since Issue Specific Hearing 2

- Further to the matters discussed at Issue Specific Hearing 2 on seascape, landscape and related matters (ISH2), the Applicant has been liaising with Natural Resources Wales (NRW), Eryri National Park (ENP) (formerly Snowdonia National Park (SNP)), Isle of Anglesey County Council (IoACC), Conwy County Borough Council (CCBC), Denbighshire County Council (DCC) and other Interested Parties (IPs), regarding a potential landscape enhancement fund.
- 2 The Applicant provided the group with a set of key principles for a fund on 15 December 2022.
- 3 The principles set out a proposal for a \$106 agreement to be agreed between the Applicant and DCC with the approval of the other parties listed above, providing funds through the operational lifetime of the project for enhancement projects within areas of Anglesey Area of Outstanding Natural Beauty (AONB), ENP and Great Orme Heritage Coast, where landscape related significant effects from the project may occur.
- 4 The Applicant and the group met on 11 January 2023 to discuss the proposed key principles.

1.2 Draft section 106 agreement

- 5 The draft agreement is under negotiation between the parties.
- On 24 January 2023, the Applicant provided a draft \$106 agreement for review by DCC, CCBC, IoACC, ENP and NRW.
- 7 The Applicant met with a representative of the group on 1 February 2023. It was communicated that a review of the drafting was being undertaken by the group, with a view to providing feedback in the near future.
- An email exchange between the Applicant and CCBC on 2 February 2023 confirmed that the draft agreement is with their Legal Section for review, as well as the legal teams from the other local planning authorities. Helpfully CCBC Legal Section has engaged with their counterparts in DCC to request their input and review of the document as they will be signatories.
- 9 The Applicant recognises that it may be challenging to reach agreement before a decision is made on the DCO application. In the event that no agreement is reached, the Applicant will consider including a requirement in the DCO to secure the agreement.



2 Tourism Agreement

- 10 Further to the matters discussed at ISH2 (Seascape, landscape and related matters), the Applicant has been liaising with CCBC regarding a potential Tourism Fund.
- 11 The Applicant provided CCBC with a set of key principles on 9 January 2023.

- 12 The proposal is to establish a contract between the Applicant and CCBC for tourism-related activities in Llandudno and the Great Orme for the period of construction ending and operation commencing, given the identification of the potential for short-term impacts on tourism in these locations.
- 13 The Applicant and CCBC met on 16 January 2023 to discuss the principles and, following the call, a draft agreement was issued for review by CCBC on 25 January 2023.
- 14 The Commercial agreement is under negotiation between the Applicant and CBCC.
