1 Introduction

- 1 Awel y Môr Offshore Wind Farm Limited (the Applicant) has prepared this guide to its Deadline 6 submission to detail the complete list of documents submitted at Deadline 6.
- 2 Table 1 also states whether documents submitted at Deadline 6 are also relevant to the marine licence (ML) process administered by Natural Resources Wales (NRW). The Applicant will provide these documents to NRW for the purposes of the marine licence determination.
- 3 For further detail on all documents submitted into the examination by the Applicant by date, please refer to the Documents Tracker (Document 6.2 of the Applicant's Deadline 6 Submission).
- 4 It should be noted that the Applicant has revised the way that documents are referenced following suggestions by the Examining Authority (ExA) at Issue Specific Hearing 2 (ISH2). From Deadline 4 onwards, any document that was submitted prior to examination will have an 'Application Reference' that is taken from the document reference provided at application stage. This application reference will sit alongside a standard deadline-specific document reference such as the documents prior to Deadline 4 have had. For clarity, the Applicant will now reference the tracked and clean version of the same document by the same reference number. For example, both the clean and tracked version of the Draft Development Consent Order have an Application reference of 3.1 and a Deadline 6 reference of 6.5.

1.1 Communication with the Department of Agriculture, Environment and Rural Affairs (DAERA) in Response to ExQ2.2.1

- 5 The Applicant contacted DAERA on 01 February 2023 to address ExQ2.2.1 which asked the following:

"Please provide a response to the Department of Agriculture, Environment and Rural Affairs (DAERA) comments to ExQ1.2.102 [REP1-057] that NIEA's Ornithology Team should be consulted regarding any additional Seabird Considerations related to any additional European / Ramsar sites or qualifying features which

have not been included in the Report to Inform Appropriate Assessment (RIAA) [APP-027]”

- 6 The Applicant asked DAERA whether it was content with the assessment undertaken or to advise if it is aware of any sites or qualifying seabird features that are missing from the RIAA.
- 7 The Applicant received a response from DAERA on 09 February 2023 which confirmed that that relevant team had been consulted with and it is *“content with the assessment undertaken and have nothing further to add”*.

1.2 NRW Addendum – Conservation Objectives for Liverpool Bay Special Protection Area

- 8 The Applicant acknowledges the addendum that NRW submitted into the examination which was accepted at the discretion of the ExA as a late Deadline 5 submission (REP5-047). NRW states that the new conservation objectives do not change the conclusions of the HRA and that the assessment still stands. The Applicant is in agreement with this advice.
