# 1 Applicant's Update on the Marine Licence Submission and Progress

- 1 The Applicant and Natural Resources Wales Marine Licensing Team (NRW-MLT) have continued to liaise with regards timescales for, and alignment of, the DCO and Marine Licence processes. Since the last update (REP6-015), at Deadline 6 on 20 February 2023, key events are summarised as follows:
- 2 **8 March 2023** – DCO Deadline 7. As proposed in the last update, the Applicant submitted to NRW-MLT the following documents:
  - ▲ a) Marine Licence Principles Rev G – in clean and tracked versions (REP7-009 and REP7-010);
  - ▲ b) Schedule of Mitigation and Monitoring Rev F (REP7-034); and
  - ▲ c) Response to Marine Licence Re-consultation comments (Document 8.21 of the Applicant's Deadline 8 submission).
- 3 Please note that items a and b (above) were also submitted into the DCO Examination at the same date. Item c is submitted to the DCO Examination as part of the Applicant's Deadline 8 submissions.
- 4 **16 March 2023** – a meeting has been arranged between the Applicant and NRW-MLT following DCO Deadlines 7 and 8, to pick up any matters relating to submissions and to the close of the DCO Examination scheduled for four days later, on 20 March 2023. Any need for further marine licensing meetings (to run concurrently with the DCO Recommendation phase) will also be discussed but are not expected to be necessary.
- 5 The Applicant has committed to sending final relevant Statements of Common Ground to NRW-MLT before the close of the Examination.
