1 Introduction

- 1 Awel y Môr Offshore Wind Farm Limited (the Applicant) has prepared this guide to its Deadline 8 submission to detail the complete list of documents submitted at Deadline 8.
- 2 Table 1 also states whether documents submitted at Deadline 8 are also relevant to the marine licence (ML) process administered by Natural Resources Wales (NRW). The Applicant will provide these documents to NRW for the purposes of the marine licence determination.
- 3 For further detail on all documents submitted into the examination by the Applicant by date, please refer to the Documents Tracker (Document 8.2 of the Applicant's Deadline 8 Submission).
- It should be noted that the Applicant has revised the way that documents are referenced following suggestions by the Examining Authority (ExA) at Issue Specific Hearing 2 (ISH2). From Deadline 4 onwards, any document that was submitted prior to examination will have an 'Application Reference' that is taken from the document reference provided at application stage. This application reference will sit alongside a standard deadline-specific document reference such as the documents prior to Deadline 4 have had. For clarity, the Applicant will now reference the tracked and clean version of the same document by the same reference number. For example, both the clean and tracked version of the Draft Development Consent Order have an Application reference of 3.1 and a Deadline 8 reference of 8.9.

1.1 Closing Submission

5 The Applicant intends to submit a closing submission setting out its overall case for the AyM development before the close of examination, as requested by the ExA. This document has not been submitted at Deadline 8 as the Applicant considers that submissions from interested parties at D8 may be relevant to consider before finalising this submission.



6 The Applicant also intends to submit a final clean and tracked copy of the draft DCO at the same time, as it anticipates reaching further agreement on Protective Provisions between Deadline 8 and the close of examination. The Applicant will provide a Validation Report for the draft DCO at this time too.

1.2 List of DCOs Referenced

- 7 The Applicant notes that the ExA requested an updated list of DCOs referenced by the Applicant to be submitted at D8 in question ExQ2.0.12.
- 8 The Applicant has reviewed submissions and can confirm that no changes to the list submitted at Appendix A of REP5-004 are required.
