## The Planning Inspectorate

Application by Keadby Generation Limited for an Order Granting Development Consent for the Keadby 3 Low Carbon Gas Power Station project.

The Examining Authority's (ExA) Record of the Unaccompanied Site Inspection (USI) that took place on 28 October 2021.

The ExA undertook the inspection by car and on foot on public roads and public rights of way. The routes were planned having regard to the Applicant's Environmental Statement and enabled the ExA to obtain views of the site of the Proposed Development and surrounding area. Timings are approximate.

Viewpoint (VP) locations are as indicated on Figure 14.5 in the Environmental Statement [APP-135].
