held with regard to the land acquisition in our response to the ExQ1's which in relation to the Trust states:

"In response, the Applicant considers that there has been extensive consultation and discussions with C&RT both prior and since receipt of document AS-001 and they have every intention of trying to reach agreement in default of which the grant and exercise of compulsory purchase powers would be both reasonable and proportionate."

We do not have comments on information submitted by other parties at Deadline 1 save for those incorporated within the Applicant's response to the Examining Authority's Written Questions and its comments on the Local Impact Report.

Updated Documents

The Applicant submits alongside this letter a Statement of Commonality of SOCG (Document Ref 9.5), an update on the progress that has been made with Affected Persons in respect of Compulsory Acquisition and Temporary Possession (Document Ref. 9.6), an updated Draft DCO (Document Ref. 2.1 [Revision 2.0]), and a schedule of updates to the Draft DCO (Document Ref. 9.7). The Applicant is providing a tracked PDF and tracked Word version of the draft DCO. The Applicant is currently unable to provide a clean version of the draft DCO in the SI template due to illness within the Applicant's Project Team, but this will be provided as soon as possible.

There are no updates to make to the Book of Reference compared to Revision 2.0 submitted at Deadline 1. The Applicant will submit an updated Book of Reference if and when due diligence results in new information.

Any further information requested by the ExA

The ExA requested further information via the Rule 17 letter dated 17 January 2022 [**PD-010**]. This is covered in detail below.

Response to Rule 17 Letter [PD-010]

Archaeology

The Applicant submits alongside this letter their responses to the questions included in the ExA's Rule 17 Letter (Document Ref. 9.8) which includes an indicative timetable for archaeological evaluation subject to access agreements and contractor appointment. The timetable is possible in principle but not yet final due to the abovementioned practical uncertainties.

Applicant's Request to adjust the project name

The Applicant regards the change to the project name as non-material particularly given that it is consistent with other external messaging on the project underway. When considering whether to carry out consultations on changes regard must be had to whether prejudice is likely to occur in the absence of such consultation. We are not aware of any potential for prejudice to arise given that the change comprises modified wording between 'Keadby 3' and 'Power Station' thus not altering the core geographical and typological descriptors of the project, so it would not be perceived by any reasonable person as a different project.



A comprehensive voluntary round of consultation is being planned by the Applicant for a proposed Material Change Application (see further down this letter). This offers a logical opportunity for the Applicant to begin using the project name (which we have started using in documents submitted into examination). We would therefore be grateful if the new project name could be changed on the PINS website to coincide with the publication of our newspaper advertising later in February relating to this voluntary consultation and we would keep in touch with your officers to advise of the dates we obtain from newspapers.

Statements of Common Ground

The Applicant committed to the submission of a number of Statements of Common Ground in its Deadline 1 Covering Letter [**REP1-001**]. The Applicant is able to provide the following updates:

- Environment Agency the Applicant is still in discussions with the Environment Agency on a draft SOCG and intend to submit an agreed SoCG at Deadline 3.
- Severn Trent Water the Applicant is still in discussions with Severn Trent Water regarding agreeing a draft SoCG. The Applicant has provided a draft SoCG to Severn Trent Water for comment and hopes to be able to submit at Deadline 3.
- UK Health Security Agency (formerly Public Health England) the Applicant is able to submit an agreed draft alongside this letter (Document Ref. 8.13). This is an agreed draft and clarifications from UK Health Security Agency are to be issued to us around 11 February.
- Keadby with Althorpe Parish Council the Applicant is able to submit an agreed SoCG alongside this letter (Document Ref. 8.14).
- Isle of Axholme and North Nottinghamshire Internal Drainage Board the Applicant stated an intention to submit a voluntary SoCG with Isle of Axholme and North Nottinghamshire Internal Drainage Board at Deadline 2. The Applicant is still in discussions with the IDB and intends to submit this at Deadline 3.

1.0 INTRODUCTION

1.1 Overview

1.1.1 The Rule 8 letter (PD-008 dated 14 December 2021) states that week commencing 11 April 2022 has been reserved for the Accompanied Site Inspection (ASI). Comments on suggested locations/ sites for the Examining Authority (ExA) to include as part of the ASI were submitted at Deadline 1 (21 December 2022) by the Applicant in their cover letter (REP1-001) and by the Canal and River Trust (REP1-023).
