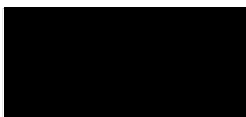
NOTIFICATION OF PROPOSED APPLICATION FOR A MATERIAL CHANGE

The Applicant writes to outline its intention to submit a Material Change Application ('the MC Application') to the Examining Authority in order that certain limited but necessary changes to the construction access arrangements and the height of certain larger structures can be submitted into the DCO examination at a future deadline, as mentioned in the Applicant's Deadline 2 Cover Letter.

This letter is independent of the Deadline 2 submission also made today, and represents Step 1 in the process advised in Planning Inspectorate's Advice Note 16 ('AN16'), March 2018. We enclose a document 'Notification of Proposed Application for a Material Change (February 2022)' containing a description of the nature and scale of the Proposed Development Changes, proposals for voluntary consultation (including timetable for carrying this out in advance of submitting the MC Application) and a plan annotated to explain the limited extensions to the Order Limits within SSE group company owned land and in Crown owned riverbed. We also enclose a GIS shapefile.

We look forward to receiving advice ('Step 2') from the Examining Authority which will allow us to finalise and implement our consultation on the MC Application which we currently expect to initiate practical preparations for around 11 February 2022 with consultation beginning 18 February for 30 days. The MC Application would then be refined and then submitted at Deadline 5 (5th April 2022).
