## 1 Comments on any information submitted for Deadline 3

### 1.1 REP3-006 Keadby Generation Limited Deadline 3 Submission - 5.5 - Planning Statement - Clean – Revision 2

1.1.1 With regard to paragraph 3.3.31 – The MMO note that references are made to the overarching Marine Policy Statement, rather than the North-East Marine Plan. The MMO would like to advise that the North-East Marine Plan was formally adopted by the Secretary of State on 23 June 2020 and as such is a material consideration. It is important that this is reflected in the submitted documentation.

### 1.2 REP3-020 Keadby Generation Limited Deadline 3 Submission - 9.9 - Applicant's Response to Examining Authority's Written Questions Responses

1.2.1 The MMO notes the Applicant's explanation for the Fish Management Plans placement within the Construction Environment Plan rather than within the Deemed Marine Licence (DML). While the preference of the MMO is for matters relating to the marine environment to be kept within the DML, the MMO understands the justification provided. The MMO do however, still require consultation on the Fish Management Plan and would still need to see this secured within the DML.
