KEADBY 3 CARBON CAPTURE POWER STATION PROJECT – APPLICATION BY KEADBY GENERATION LIMITED FOR AN ORDER GRANTING DEVELOPMENT CONSENT FOR THE KEADBY 3 CARBON CAPTURE POWER STATION – LAND AT THE KEADBY POWER STATION SITE, TRENTSIDE, KEADBY, SCUNTHORPE, LINCOLNSHIRE, DN17 3EF

THE PLANNING ACT 2008

The Applicant writes in relation to the Proposed Development Changes which the Examining Authority ('ExA') was previously notified of in a letter dated 1 February 2022 [REP2-012] and accompanying report [REP2-013]. The ExA responded in a letter dated 9 February 2022 [PD-011] which acknowledged the notification and included further advice and information including in relation to consultation.

The Applicant has had regard to that advice and information alongside that included in Advice Note 16: How to request a change which may be material ('AN16') in its preparation of this submission of a Change Request.

Proposed Development Changes

As mentioned in the Notification of Proposed Application for Material Change [REP2-012], the Proposed Developments Changes have resulted from design contractor involvement, which has continued to refine the detail of this 'First of a Kind' Project implementation, and have been kept to a minimum where possible.

The Changes remain the same as those set out in the abovementioned notification and are set out in Table 1 below and are described in more detail in the documents submitted alongside this letter.

1	Inclusion of riverbed within the Waterborne Transport Offloading Area (Railway Wharf).
2	Changes to the Additional Abnormal Indivisible Load Route, largely within SSE land and all within existing Order Limits.

3	Increase to the maximum heights of the carbon dioxide absorbers/ stacks, if two are installed.
4	Increase to the maximum heights of the carbon dioxide stripper column.
5	Increase in proposed soil import volumes to create a suitable development platform.

This application includes all of the necessary information to include in a request to make a material change to an application after it has been accepted for examination, as set out in Figure 3 of Advice Note 16: How to request a change which may be material. Each point in Figure 3 is covered off in the following documents:

1. A clear description of the proposed change, including any new/alterd works and any new/alterd ancillary matters can be found in the Proposed Development Changes: Environmental Statement Addendum Main Volume (**Document Ref. 10.7**) and the Proposed Development Changes: Environmental Statement Addendum Updated Chapters and Appendices (**Document Ref. 10.8**).
2. A statement setting out the rationale and pressing need for making the change, with reference to the Examination Guidance, any relevant National Policy Statement(s) as appropriate and any other important and relevant matters can be found in the Proposed Development Changes: Rationale and Need Statement (**Document Ref. 10.5**).
3. A full schedule of all application documents of all application documents and plans listing consequential revisions to each document and plan or a 'no change' annotation can be found in the Proposed Development Changes: Document Schedule (**Document Ref. 10.2**).
4. An update of any consents/licences required. The Proposed Development Changes do not cause any change to the other consents/licences required or their status or progress. Nevertheless the Applicant intends to provide an update for the Proposed Development at Deadline 6 (which will include the Proposed Development Changes if they have been accepted by the ExA).
5. Tracked Word, tracked PDF and clean PDF versions of the draft DCO showing each proposed change be found in the Draft Development Consent Order (Deadline 5 + Proposed Development Changes) (**Document Ref. 2.1**). A tracked version of the Explanatory Memorandum (Proposed Development Changes) (**Document Ref. 2.2**) has also been provided. 'Tracked' in this context means compared to the (non change related) Deadline 5 Draft DCO.
6. Details relating to proposed changes to the Order Land can be found in the Proposed Development Changes: Consent to Provision Authorising Compulsory Acquisition (Keadby Developments Limited) (**Document Ref. 10.4**). This provides consent from Keadby Developments for the sole element of compulsory acquisition that engages the Infrastructure Planning (Compulsory Acquisition) Regulations 2010 (the CA Regulations). For the avoidance of doubt, no other third party land compulsory acquisition is provided for within this Change Request; additional land is shown in river bed but being Crown land is not subject to compulsory acquisition, while we have removed a small section of Environment Agency land from the Proposed Development Changes, which had been shown in the Notification of Proposed Application for Material Change [**REP2-012**]. This position is further confirmed in the

enclosed updated Book of Reference specific to the Proposed Development Changes (**Document Ref. 3.1**, tracked and clean versions).

7. Environmental information confirming that effects of the Proposed Development Changes have been adequately assessed and that the environmental information has been subject to publicity can be found in the Proposed Development Changes: Environmental Statement Addendum Non Technical Summary (**Document Ref. 10.6**); Proposed Development Changes: Environmental Statement Addendum Main Volume (**Document Ref. 10.7**); Proposed Development Changes: Environmental Statement Addendum Chapters and Appendices (**Document Ref. 10.8**); and Proposed Development Changes: Environmental Statement Addendum Updated Selected Figures (**Document Ref. 10.9**). Confirmation that any consultation bodies who might have an interest in the proposed changes have been consulted can be found in the Proposed Development Changes: Consultation Statement (**Document Ref. 10.3**).
8. As additional non-statutory consultation has been carried out by the Applicant, a Consultation Statement confirming who has been consulted in relation to the proposed change along with copies of any consultation responses received by the Applicant can be found in the Proposed Development Changes: Consultation Statement (**Document Ref. 10.3**).
