However it is our understanding that this submission was notified to all interested parties by PINS in early April following the submission of the Change Request. The Applicant provides in Table 2.7 of Document 9.19 the Applicant's response to the UKHSA Deadline 6 submission and a summary of the overall position reached with respect to UKHSA.
