1.0 INTRODUCTION

1.1 Overview

- 1.1.1 This Proposed Development Changes: Document Schedule (**Application Document Ref. 10.5**) has been prepared on behalf of Keadby Generation Limited ('the Applicant'). It forms part of the application (the 'Application') for a Development Consent Order (a 'DCO'), that has been submitted to the Secretary of State (the 'SoS') for Business, Energy and Industrial Strategy, under Section 37 of 'The Planning Act 2008' (the '2008 Act').
- 1.1.2 The Applicant is seeking development consent for the construction, operation and maintenance of a new low carbon Combined Cycle Gas Turbine (CCGT) Generating Station ('the Proposed Development') on land at, and in the vicinity of, the existing Keadby Power Station, Trentside, Keadby, Scunthorpe, DN17 3EF (the 'Proposed Development Site').
- 1.1.3 The Proposed Development is a new electricity generating station of up to 910 megawatts (MW) gross electrical output, equipped with carbon capture and compression plant and fuelled by natural gas, on land to the west of Keadby 1 Power Station and the (under commissioning) Keadby 2 Power Station, including connections for cooling water, electrical, gas and utilities, construction laydown areas and other associated development. It is described in Chapter 4: The Proposed Development of the Environmental Statement (ES) (ES Volume I APP-047).
- 1.1.4 The Proposed Development falls within the definition of a 'Nationally Significant Infrastructure Project' (NSIP) under Section 14(1)(a) and Sections 15(1) and (2) of the 2008 Act, as it is an onshore generating station in England that would have a generating capacity greater than 50MW electrical output (50MWe). As such, a DCO application is required to authorise the Proposed Development in accordance with Section 31 of the 2008 Act.
- 1.1.5 The DCO, if made by the SoS, would be known as 'The Keadby 3 (Carbon Capture Equipped Gas Fired Generating Station) Order' ('the Order').
- 1.1.6 Since the application was submitted, additional engineering and design studies have been completed, resulting in a number of Changes to the Project which form the Changes Application to be submitted on 10 May 2022.

1.2 The Purpose and Structure of this Document

1.2.1 The purpose of this document is to assist the examination of the Material Change Application for a number of Proposed Development Changes by providing a list of documents that make up the Material Change Application submitted to the SoS.





- 1.2.2 This document fulfils criteria set out in Advice Note 16: How to request a chance which may be material which in Figure 3 requests the following:
 - "A full schedule (Applicants may find it helpful to mirror the information required on the prescribed application form paragraph 1 of Schedule 2 of The Infrastructure Planning (Applications: Prescribed Forms and Procedure) Regulations 2009) of all application documents and plans listing consequential revisions to each document and plan or a 'no change' annotation. The schedule should include an update of any consents/licences required and whether (given the proposed change to the application) there will be any impediment to securing the consents/licences before the Examination is concluded."
- 1.2.3 The Documents are listed below in Section 2 (Table 2.1) of this document.





2.0 PROPOSED DEVELOPMENT CHANGE APPLICATION DOCUMENTS

- 2.1.1 A number of documents relating to the Proposed Development Change were previously submitted at Deadlines 5 and 6, however, these are to be withdrawn and a complete set of documents be re-submitted alongside this letter.
