Keadby 3 Carbon Capture Power Station – Deadline 7a Representation, response to Rule 17 Questions of 26 May 2022 Environment Agency Unique Interested Party Ref – KDB3-SP091

In accordance with the Examination Timetable, please find below the Environment Agency's submission in relation to the Examining Authority's Rule 17 Questions of 26 May 2022, Question 4, which reads:

The ExA would invite all Interested Parties to whom this question is directed to summarise their position at Deadline 7a (12.00pm (noon) on Monday 6 June 2022), especially in regard to:

- i) any outstanding objection(s):
- ii) protective provisions;
- iii) compulsory acquisition/ temporary possession; and
- iv) the status of any side agreement, interface agreement or other relevant agreements they consider necessary to provide relevant protections or mitigations from the Proposed Development.

The Environment Agency has an outstanding objection (lodged on 2 September 2021 – see additional submission AS-002) in respect of the Applicant's intention to acquire rights affecting several plots of land where existing easements will be impacted etc. At the time the objection was lodged it was unclear if/how the proposed acquisitions would affect the Environment Agency's flood risk management operations.

Since this time, we have worked with the Applicant's Agent to gain clarity on these matters and the table in Appendix 1 attached provides the latest position in relation to the various plots where the Environment Agency has a land interest. In summary, we have received and are currently considering:

- 1. a draft Deed of Variation relating to plots 3, 10 and 26 (received 20 May 2022);
- 2. a draft Deed of Variation relating to plot 30 (received 26 April 2022).

Outstanding documents are still to be drafted/agreed relating to:

- 1. an easement/options agreement in respect of plot 52;
- 2. securing access around plot 80a;
- 3. temporary possession in relation to plots 31, 46, 47, 53 and 54.

The Environment Agency is of the view that all the outstanding issues are capable of resolution by agreement. Accordingly, we will continue to work on finalising the required agreements during the decision period and we will write directly to the Secretary of State when we are in a position to withdraw the outstanding objection.
