### **Five Estuaries Offshore Wind Farm Project – Change Request**

Dear Mr Johansson,

Further to the Rule 8 Letter dated 22 October 2024, we note the Examining Authority's (ExA) Procedural Decision regarding the Applicant's request to make 10 changes to the accepted Application.

In respect of Proposed Change 9, the Applicant wishes to clarify in response to the ExA's comments that a new Land Plot has not been created by this change. Rather, an extension to an existing Land Plot (20-003) has been made to the north, as well as a reduction to the same existing Land Plot in the west. The Applicant can confirm that no new land interests have been brought in by extending the northern boundary of Land Plot 20-003. Therefore the Applicant considers that the creation of a new Land Plot specifically for this purpose is not required.

As such, the Applicant does not intend to submit additional revisions of the onshore Land Plans [AS-019] or the Book of Reference [AS-035] to show any changes on this point. The Applicant does however note that following review, there is an omission in the version of the Book of Reference submitted with the change request, namely that the land area in the description for the (as changed) plot 20-003 shows as 173,861 sq m, this should be 69,153 sq m. The Applicant accordingly encloses with this letter an updated version of the Book of Reference (Revision D), in both Tracked and Clean versions, correcting that and respectfully requests that the Examining Authority accepts this as an additional submission.
