Navigation Risk Assessment and Outline Landscape and Biodiversity Management and Monitoring Plan

Please note that these documents are being provided as a substitute for the current documents on the Planning Inspectorates project website and not as a new revision. It is noted in Written Question 1.0.4 that there were apparent errors in these documents. After checking, it was confirmed that the documents that the Applicant provided at submission included complete words, but the file appears to have corrupted on the PINs website. As a result, the Applicant is providing these documents again, but the versions provided here have not been changed in any way and are still Revision 0 as a result.

The other Revision 0 documents are new documents that have not previously been submitted by the Applicant.

Land Plans and Updated Book of Reference

The updates to these documents are related to further consistency checks, requests from the Examining Authority's First Written Questions and an issue with the plot boundaries in one particular area which led to the Red Line Boundary being reduced by approximately 30 square metres. The Applicant is in the process of writing to the parties who are affected by the Red Line Boundary change to advise that the plot boundaries have been re-drawn; this will be done before Deadline 3. The other changes do not necessitate any updates to landowners.

Rule 17 Letter [PD-008]

The Examining Authority (ExA) issued a Rule 17 Letter [PD-008] on 8 December 2022 requesting clarity relating to Document 5.2 – RDF Supply Assessment (Revision 1) [REP1-006] provided at Deadline 1. An amended document addressing the points in the Rule 17 letter was provided to the ExA on 14 December 2022. The revision of this document has been recorded in the Document 1.2 – Application Guide [Revision 3] submitted as part of this Deadline 2 submission.
