1. INTRODUCTION

- 1.1 Further to Q7.0.20 of the Examining Authority's First Written Questions (**EXQ1**) (PD-007), the Applicant has set out in **Table 1.1** below details of each plot within the Application Site for which it is applying for powers of compulsory acquisition and temporary possession.
- 1.2 Table 1.1 sets out the purpose for which each plot has been included.
- 1.3 The first column identifies the plot number (as shown on the Land Plans (REP2-014)) and used in the Book of Reference (REP2-008). The second and third columns relate to the specific Land Plan sheet number and the relevant Work number as shown on the Works Plans (APP-016, APP-017 and APP-018). The final column gives a description of the Work that is intended to be carried within each plot.
