**NORTH LINCOLNSHIRE GREEN ENERGY PARK PROJECT**  
**THE PLANNING ACT 2008**

### ***Updated Guide to Application***

All new and revised documents are referenced in the enclosed updated Application Guide (Document 1.2 – Application Guide [Revision 5]). A clean and tracked version has been provided for clarity.

### ***Explanatory Memorandum and Statement of Reasons***

The Applicant has not submitted an updated Explanatory Memorandum (document reference 2.2) at this deadline. We note that the Applicant is requested to submit another updated dDCO at Deadline 5 (21<sup>st</sup> February) so will submit an up-to-date Explanatory Memorandum at this point, including updates from both Deadline 4 and Deadline 5.

The Applicant also intends to submit an updated Statement of Reasons (document reference 3.2) at Deadline 5 to reflect the changes made at Deadlines 3, 4 and 5 to a number of the Application documents including the Book of Reference (document reference 3.1), Land Plans (document reference 4.2) and the dDCO (document reference 2.1).

### ***Environmental Statement Chapter 3: Project Description and Alternatives***

ES Chapter 3: Project Description and Alternatives has been amended in response to refs. 47 and 51 in Document 9.22.

### ***Environmental Statement Chapter 5: Air Quality***

Following discussions at Issue Specific Hearing 3, and further engagement with North Lincolnshire Council, ES Chapter 5: Air Quality has been updated to include an odour assessment. Please note that this updated chapter has also been sent directly to North Lincolnshire Council.

### ***Environmental Statement Chapter 12: Archaeology and Cultural Heritage***

North Lincolnshire Council raised in an email exchange on 13 January that the ES Chapter 12: Archaeology and Cultural Heritage was missing all nine figures listed in the contents of Appendix B Archaeological Desk Based Assessment. The updated chapter submitted at this deadline includes these figures.

A tracked version of this document has not been included as there is no change to text, only the insertion of figures at e-page 123 to 135.

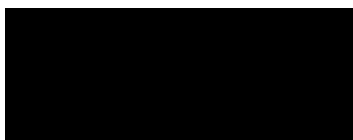
### ***Environmental Statement Annex 6: Navigational Risk Assessment***

Following engagement with Associated British Ports as part of the Statement of Common Ground process, the Preliminary Navigational Risk Assessment (NRA) has had some minor amendments. Please note the amended NRA submitted at this deadline has also been shared directly with Associated British Ports. An initial Draft SoCG with Associate British Ports has been submitted at this deadline which includes reference to this updated document.

### **Statement of Common Ground update – Openreach Limited**

The Applicant has been engaging with Openreach Limited who have confirmed that the Protective Provisions included within the draft Order are acceptable and that they have no further concerns with the Project. The Applicant will continue to liaise with Openreach as the Project progresses. As such, both parties are content that a SoCG is not required.
