ES Chapters 7 and 19 and Annex 8: OEMP

The Applicant has accepted the ExA's recommendation for a noise requirement. In support of this, the text in the noise chapter (REP7-014), mitigation chapter (REP7-016) and Operational Environmental Management Plan (OEMP, REP7-020) have been updated to remove the two tables of noise limits (Tables A and B) and instead reference the noise limits in the noise requirement. All other commitments, to mitigate and minimise noise as far as reasonably practicable and to demonstrate compliance with the noise requirement, have been retained.

The Applicant's Case under Section 127 and 138 Planning Act 2008 – Statutory Undertakers' Land

At CAH1 the ExA asked the Applicant to provide an update on the position with statutory undertakers by Deadline 8. This document sets out the latest position and where the Applicant has reached agreement with statutory undertakers. This document also sets out the Applicant's position in relation to sections 127 and 138 of the Planning Act 2008 in respect of statutory undertaker's land affected by the Scheme, where the Applicant has not been able to reach agreement.



Anglian Water

The Applicant has been made aware of the submissions made by Anglian Water for Deadline 8. The Applicant did provide information requested by Anglian Water on 28 February, following a call on 23 February, and to-date has not received any feedback or commentary on the information submitted, despite repeated requests for this. Notwithstanding this the Applicant will be preparing the Technical Summary requested and will look to meet with Anglian Water before the close of the Examination to resolve any outstanding issues as soon as possible.

Outline Employment Skills Policy

The Outline Employment and Skills Policy sets out the approach that will be adopted by the Applicant to promote local employment opportunities and ensure the economic benefits of the Project are maximised locally. The outline policy will form the basis for a final Employment and Skills Plan, which will be prepared and submitted by the Applicant prior to the commencement of the NLGEP development. It has been developed in conjunction with the Economic and Employment Group which has been established for the project to help ensure that the economic benefits of the Project are maximised locally. The group includes various regional stakeholders, such as North Lincolnshire Council, Department for Work and Pensions North Lincolnshire, Hull and Humber Chamber of Commerce, North Lindsey College, CATCH, Greater Lincolnshire Local Enterprise Partnership ('Greater Lincolnshire LEP'), Humberside Engineering Training Association ('HETA'), STEM Learning, Engineering UTC Northern Lincolnshire, and Lincolnshire Chamber of Commerce.

dDCO Validation Report

The Applicant is preparing the validation report for the draft DCO, yet this is yet to be received and will be submitted as a late submission once finalised and received.
