1 INTRODUCTION

- 1.1.1 The Development Consent Order (**DCO**) application for North Lincolnshire Great Energy Park scheme was submitted on 31 May 2022 and accepted for examination on 27 June 2022.
- 1.1.2 The purpose of Table 1.1 in this document is to set out the changes made to the draft Development Consent Order (**dDCO**) from that submitted on 31 May 2022 (Version 0) (**APP-007**).
- 1.1.3 These changes were made principally to reflect the Planning Inspectorate's comments on 23 June 2022, under section 55 of the Planning Act 2008 following acceptance of the application.
- 1.1.4 The purpose of Table 1.2 in this document is to set out the changes made to the dDCO from that submitted on 28 September 2022 (Version 1) (**AS-006**).
- 1.1.5 These changes were made principally to reflect the Examining Authority's first set of written questions (**PD-007**), to reflect the points explored by the Examiner and other interested parties at Issue Specific Hearing 1: Draft Development Consent Order, which took place virtually on 17 November 2022.
- 1.1.6 The purpose of Table 1.3 in this document is to set out the changes made to the dDCO from that submitted on 15 December 2022 (Version 2) (**REP2-004**).
- 1.1.7 The purpose of Table 1.4 in this document is to set out the changes made to the dDCO from that submitted on 7 February 2023 (Version 3) (**REP4-004**).
- 1.1.8 The purpose of Table 1.5 in this document is to set out the changes made to the dDCO from that submitted on 21 February 2023 (Version 4) (**REP5-006**).
- 1.1.9 The purpose of Table 1.6 in this document is to set out the changes made to the dDCO from that submitted on 20 March 2023 (Version 5) (**REP6-004**).
- 1.1.10 The purpose of Table 1.7 in this document is to set out the changes made to the dDCO from that submitted on 28 April 2023 (Version 6) (**REP8-004**).
