# Statements of Common Ground

Whilst the Applicant has sought to engage with each party to progress the SoCGs as far as possible, it has not been possible in all instances to agree a final signed version. Nevertheless, it is considered helpful to the ExA to see the final draft versions, which the Applicant considers to be a good indication of the points of agreement and disagreement between each SoCG party and the Applicant.

The Statement of Commonality submitted at this deadline includes a full explanation as to status of each SoCG. If any further final SoCGs can be agreed between Deadline 9 and close of the Examination, the Applicant will provide these to the ExA.

# **Updated Guide to Application**

All new and revised documents are referenced in the enclosed updated Application Guide (Document 1.2 – Application Guide [Revision 10]). A clean and tracked version has been provided for clarity. As requested by the Examining Authority, an additional column with the examination reference has been added to the document. Where a document is new and does not yet have an examination reference TBC has been used.

# Deed of Development Consent Obligations

It is noted that signed final versions of any Development Consent Obligations associated with the Application is requested to be submitted at Deadline 9 if required. The Deed of Development Consent Obligations (section 111 agreement) to be entered into with North Lincolnshire Council in relation to



a contribution for improvements to the junction in the vicinity of Neap House has been agreed between the Applicant and the Council. The Deed is awaiting signatures by both parties and the Applicant hopes to submit a completed copy by the close of examination.

# Book of Reference and Land Plans update

The Book of Reference and Land Plans are in the process of being updated and will be provided to the Examining Authority as soon as possible following Deadline 9 and prior to the close of examination on 15 May 2023.

## **Combined Heat and Power Assessment**

The Combined Heat and Power Assessment has been updated to reflect the Applicant's progress in securing off takers and the application for the Green Heat Network Fund which demonstrates the high level of preparedness.

## Updated ES AQ Chapter

ES Chapter 5: Air Quality has been updated at this deadline to address concerns from local residents that Flixborough and Amcotts were not named on figures within the documents. These have been updated to include those names.

## Updates following Natural England engagement



Following engagement with Natural England a number of application documents have been updated to address outstanding concerns. These include; ES Chapters 14 and 18, and ES Annex 7 CoCP.

Additional amends have also been made to ES Chapter 10 and Document Reference 5.9 - Report to inform HRA alongside a final and signed SoCG with Natural England, however these are currently with Natural England for final review and are not ready to submit at this deadline, largely as a result of time lost to additional bank holidays and Natural England strike days. These documents will be submitted as soon as possible following Deadline 9, and prior to close of examination on 15 May 2023.

## Archaeological Impact Assessment and Overarching Mitigation Strategy

These documents have been produced as a result of engagement with North Lincolnshire Council. NLC has drafted these documents prior to submission and have co-designed the Mitigation Strategy alongside the Applicant.

### **Provision of Closing Submissions**

The applicant wants to ensure that Closing Submissions are complete and comprehensive. Therefore, we are proposing to wait until the position on HRA is confirmed, as per the Natural England update above. As such the Applicant respectfully requests that the Examining Authority accepts Closing Submissions as soon as possible following the confirmation of the HRA position, and prior to close of examination on 15 May 2023.
