1. Introduction

1.1 Introduction

- 1.1.1 This document has been prepared to accompany an application by Rampion Extension Development Limited (hereafter 'RED') ('the Applicant') for a Development Consent Order (DCO) under Section 37 of the Planning Act 2008 for a new offshore windfarm 'Rampion 2' (the 'Proposed Development') with an output in excess of 100MW.. The Proposed Development is adjacent to the Rampion Offshore Windfarm (referred to as 'Rampion 1') in the English Channel, 13km to 25km off the Sussex coast. The Proposed Development also includes offshore and onshore electricity transmission infrastructure, including a new onshore substation that will connect to the existing National Grid substation at Bolney, Mid Sussex.
- 1.1.2 As the Proposed Development will have a capacity greater than 100MW it is defined as a Nationally Significant Infrastructure Project (NSIP) under Section 15(3) of the Planning Act 2008. It, therefore, requires an application for a DCO to be submitted to the Planning Inspectorate under the Planning Act 2008. The Planning Inspectorate will examine the application for the Proposed Development and make a recommendation to the Secretary of State (SoS) for the Department for Energy Security & Net Zero (DESNZ) to grant or refuse consent. On receipt of the report and recommendation from the Planning Inspectorate, the SoS will then make the final decision on whether to grant the DCO.

1.2 Purpose of this Document

- **Tables 1.1 to 8.1** in the Application Document Tracker (Document Reference: **1.6**) provide a full list of all documents submitted with the Application. This includes the revision numbers for each document and the relevant statutory provision that the documents are submitted pursuant to.
- 1.2.2 That document is intended to be a live document and the tables will be updated accordingly whenever new or additional revisions are submitted following acceptance of the Application or during the examination.
- 1.2.3 The tables included show the latest version of each document highlighted in green. Superseded versions will be shown greyed out. The tables will be updated to include the relevant examination library reference for each document once these become available on the Planning Inspectorate's website.
- 1.2.4 This Guide to the Application provides a brief overview of the Application for the DCO Proposed Development and signposts to the documents that make up the Application submitted to the SoS, so that readers of the Application can easily find any documents or information that they are looking for.
- 1.2.5 Regulation 5 of the Infrastructure Planning (Applications: Prescribed Forms and Procedure) Regulations 2009 (as amended) ('APFP Regulations') sets out the documents that all DCO applications must include. It also provides at Regulation 5(2)(o) and (q) for the submission of "any other documents considered necessary"

to support the application" as well as "any other plans, drawings and sections necessary to describe the proposals".

- 1.2.6 Regulation 6 of the APFP Regulations sets out specific documentation required in support of DCO applications for particular types of development. Regulation 6(4) applies to the DCO Proposed Development as an application for the construction of a pipeline. Required details outlined in Regulation 6(4)(a), (b), (c), (d), (e) and (f) are set out on the Application Form (Document Reference 1.2). The required details in Regulation 6(4)(g) are set out in the Land Plans (Document Reference 2.1.2 and 2.8), Draft DCO (Document Reference 3.1) and the Statement of Reasons (Document Reference 4.1).
- 1.2.7 The Applicant has advised the SoS under Regulation 8(1)(b) of the Infrastructure Planning (Environmental Impact Assessment (EIA)) Regulations 2017 ('EIA Regulations') that it proposes to provide an Environmental Statement (ES) in respect of the DCO Proposed Development. The DCO Proposed Development is, therefore, EIA development under Regulation 6 of the Infrastructure Planning (Environmental Impact Assessment) Regulations 2017.
- 1.2.8 This guide provides a brief overview of the documents that have been submitted to satisfy the APFP Regulations and EIA Regulations to the extent that it lists the documents submitted under those Regulations. Full details on compliance with the EIA Regulations are contained within the ES.

5. Category 4: Compulsory Acquistion Information

- 5.1.1 This category contains compulsory acquisition information comprising the Statement of Reasons, Funding Statement and Book of Reference. These should be read alongside the Lands plans and draft DCO.
- 5.1.2 Compulsory acquisition information is required because powers of compulsory acquisition are being sought from the Secretary of State.
- 5.1.3 The Statement of Reasons explains why the powers of compulsory acquisition sought in the draft DCO are necessary in order to implement the Project, and why there is a compelling case in the public interest to grant those powers.
- 5.1.4 The Funding Statement explains how the proposed compulsory acquisition would be funded.
- 5.1.5 The Book of Reference sets out those interests over which the powers of compulsory acquisition are sought. It also notes land where powers of temporary possession would apply and provides information on where the Applicant would propose to restrict existing rights or impose new restrictive covenants over land with the Order Limits.

6. Category 5: Reports

- 6.1.1 This category contains various reports and statements that are required to be provided in support of the Application, including statutory nuisance.
- 6.1.2 The Consultation Report and associated appendices present the consultation activities which the Applicant has carried out in relation to its proposals for the Project, the responses to these consultation activities and how the Project has had regard to the responses. The Appendices are provided in two parts
- 6.1.3 To inform the Habitat Regulations Assessment (HRA), the Report to Inform Appropriate Assessment (RIAA) contain the information necessary for the competent authority to carry out the appropriate assessment required under the relevant habitat legislation. The Applicant has also provided a 'Without Prejudice' HRA Derogation Case.
- 6.1.4 The Statutory Nuisance Statement explains whether the Project would cause any statutory nuisance with regards the Environmental Protection Act 1990.
- 6.1.5 This category also contains details of consents and licences which are required under other legislation to deliver the project.
- 6.1.6 This category also contains the Grid Connection and Cable Statement which provides details of the proposed offshore and onshore cable route and cable installation methods and the Safety Zone Statement which sets out whether safety zones will be applied for. A draft Marine Conservation Zone assessment is also provided.
- 6.1.7 The Planning Statement presents and reviews the Rampion 2 proposals within the context of planning policy.
- 6.1.8 The Design and Access Statement sets out the design and landscaping parameters that the Applicant proposes to apply to the Onshore Substation when undertaking detailed design.
- 6.1.9 The Site Characterisation Report provides a detailed description of the site.
- 6.1.10 Table 5-1 provides a list of the documents in this category.

- 7.1.4 Volume 2 are the principal chapters of the ES which present the assessment by aspect.
- 7.1.5 Volume 3 contains the figures referenced in the chapters, presented in order.
- 7.1.6 Volume 4 comprises the appendices supporting the assessment. This includes the Scoping Opinion for the Project, which was provided by the Planning Inspectorate in August 2020 and is included for reference.

8. Category 7: Other Documents

- 8.1.1 This category contains various additional documents which the Applicant has chosen to submit in support of its Application.
- 8.1.2 The Outline Operational Drainage Plan sets out proposals for operational drainage at the onshore substation site and extension to the National Grid Bolney substation.
- 8.1.3 The Outline Code of Construction Practice (CoCP) is an overaraching document that sets out parameters for construction of the onshore cable and substation that the Project will require of its contractors. This sets out approaches and commitments to mitigate impacts on all onshore environmental aspects. TheOutline Construction Method Statement (CMS) is one element of this which focusses on construction methiods and management for the onshore cable and substation. Both documents are provided in outline; detailed documents in accordance with these will be provided per construction stage post consent.
- 8.1.4 The Outline Site Waste and Soils Management Plans will present how materials will be managed and disposed of, and how soil will be stored and restored during construction.
- 8.1.5 The Outline Travel Plans and Construction Traffic Management Plan will set out how traffic will be managed during construction and what measures will be put in place to manage travel to and from site both during construction and operation.
- 8.1.6 The Outline Public Rights of Way Management Plan presents how access to public rights of way will be managed during construction to reduce disruption to users.
- 8.1.7 The Outline Marine and Onshore Archaeological Written Schemes of Investigation describe how archaeology will be identified, recorded and either avoided or excavated.
- 8.1.8 The Outline Landscape and Ecological Management Plan contains details of the landscaping and habitat creation proposed by the project. This comprises proposals for the reinstatement of the cable route and screening planting and habitat creation at the onshore substation.
- 8.1.9 The Outline Project Environmental Management Plan sets out the framework for the Final Project Environmental Management Plan including the controls that are proposed to manage the environmental risks associated with the construction and operation of the offshore components of the project. The Outline Offshore Operations and Maintenance Plan provides an outline of reasonably foreseeable offshore maintenance activities and the broad approach to be taken for each activity associated with the project.
- 8.1.10 The Outline Scour Protection and Cable Protection Plan sets out the information to be included in the Final Scour Protection and Cable Protection Plan (the Final Plan) which will provide information on how scour and cable protection will be managed across the development site, proposed installation methods and locations where protection will be used.

- 8.1.11 The Outline Marine Mammal Protocols set out mitigation measures for the protection of marine mammals during piling and clearance of Unexploded Ordnance.
- 8.1.12 The In Principle Sensitive Features Mitigation Plan sets out measures for the protection of sensitive features from offshore contruction activities.
- 8.1.13 The Offshore In Principle Monitoring Plan sets out the basis for delivering offshore monitoring measures..
- 8.1.14 The Fisheries Liaison and Co-existence Plan sets out how the project will engage with the fishing industry during construction and operation.
- 8.1.15 The Outline Diver Communication Plan presents how the project will communicate with divers working in the area and mititgate potential impacts from piling activities.
- 8.1.16 The Evidence Plan Report sets out how the evidence plan process has been followed for the HRA and for the wider consultation on the EIA.
- 8.1.17 The Commiments Register summarises the mitigation measures contained in the ES and highlights where these are secured in the DCO or in the Marine Licence principles document or alternativily in any of the certified plans.
- 8.1.18 The Outline Skills and Employment Strategy presents the strategy the Applicant will follow to encourage improvements in local skills and employment opportunities arising from the project.
