in relation to the application for an order to grant development consent for the Rampion 2 Offshore Wind Farm consisting of an offshore generating station adjacent to and forming an extension to the existing Rampion Offshore Wind Farm, at the location approximately 13km south of the Sussex coast located to the west and south of the existing Rampion Offshore Windfarm, and all infrastructure required to transmit the power generated to the Bolney National Grid substation, which will require to be extended (the "Proposed Development"). The offshore generating station is located in an area approximately 196km2. The onshore cable corridor is approximately 38.8km long from the landfall at Climping, West Sussex to a new substation at Oakendene, 2km east of Cowfold, West Sussex and then to the existing Bolney National Grid Substation, at Twineham, Mid Sussex. The onshore elements of the Proposed Development fall within the administrative boundaries of the following host authorities:

- Arun District Council;
- Horsham District Council;
- Mid Sussex District Council (MSDC);
- South Downs National Park Authority (SDNPA); and
- West Sussex County Council (WSCC).

The deadline for representations to be received by the Planning Inspectorate under section 56 of the Planning Act 2008 was 6 **November 2023**, save in the case of the consultation bodies listed in the Schedule hereto for which the deadline is 17 **November 2023**, as notified to those parties by letter dated 18 October 2023.
