This property was originally part of Bankfield Grange; Title Deed SX148008 and the property now known as Taintfield; Title Deed SX17882. It is now a separate property. All rights of access over the Private Means of Access (PMA) roadways, known as King's Lane and Moatfield Lane in Title Deeds WSX148008 and SX17882 were transferred to, and written into, Little Park Farm's Title Deed WSX188058. Some of these rights have been omitted from the Book of Reference and the corrections to the Book of Reference shown in the attached spreadsheet should be applied.

RED has stated in separate correspondence that any access restrictions, amendments of rights or notification of closures will be communicated in advance in writing to all residents and businesses with affected rights of access as recorded in the Book of Reference or successor document so the Book of Reference should accurately reflect these rights.
