Thank you for your message. For some reason my representations did not get through to you.

I did not keep a copy. Briefly I wanted to express deep concerns about the traffic congestion that is already affecting Cowfold badly on the A 272 and which will be seriously affected by extra traffic of HOVs and LOVs at Oakenhede estate. The second issue is to ask that attention is paid to the environment in and beyond the Cowfold stream area which is highlighted by the brilliant report from [\[redacted\]](#) on the bird and animal life which is special to the area and the long term danger of severe damage to trees and bird life. I hope the inspectorate on their visit on 14 May will have a fuller look at that area.

Finally I fully support the views of the Cowfold Campaign group. We must support more wood farms but not at the expense of our environment.
