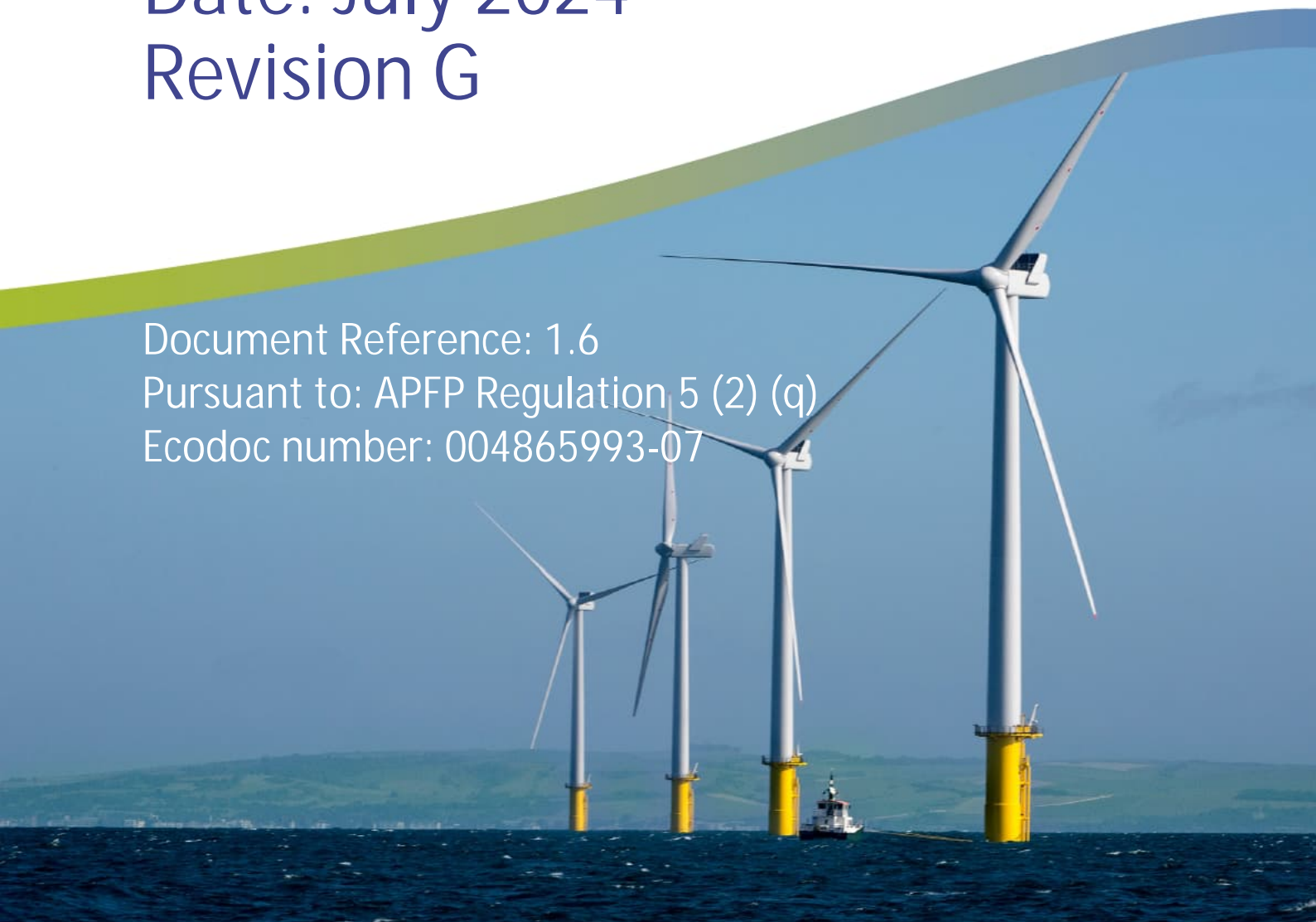

# 1. Introduction

## 1.1 Overview

Rampion Extension Development Limited (hereafter referred to as 'RED') (the 'Applicant') is developing the Rampion 2 Offshore Wind Farm Project ('Rampion 2') located adjacent to the existing Rampion Offshore Wind Farm Project ('Rampion 1') in the English Channel.

- 1.1.1 Rampion 2 will be located between 13km and 26km from the Sussex Coast in the English Channel and the offshore array area will occupy an area of approximately 160km. A detailed description of the Proposed Development is set out in Chapter 4: The Proposed Development, Volume 2 of the Environmental Statement (ES), submitted with the DCO Application [APP-076].

## 1.2 Purpose of this Document

- 1.2.1 **Tables 1.1 to 8.1** below provide a full list of all documents submitted with the Application. This includes the revision numbers for each document and the relevant statutory provision that the documents are submitted pursuant to.
