I AM WRITING TO EXPRESS MY STRONGEST CONCERN REGARDING RAMPION 2 AND ITS AFFECT ON MY HOME AND OUR COMMUNITY

with significant numbers or enormous and abnormal HGV,s the affect will be to destroy our way of life have a significant affect on daily walkers, horse rider's bicycles and destroy our verges and prevent local people using Kent street The traffic and noise levels for 6-8 months will destroy our way of life

the traffic along the A272 will be a disaster!

rampion traffic will increase already heavy traffic flow with hgv lorries and vans clogging up the entrance to Kent Street a single lane track and causing sever congestion and pollution

• The traffic on the A272, which we all know will be badly affected by the Rampion vehicles queueing to turn in and out of Kent Street, and the two Oakendene Compounds, as well as causing congestion in the Cowfold Air Quality Management Area.

What will Rampion do about this?

The justification reports from Rampion are confused and undeliverable and best and catastrophic at worst

There is some sort of plan to reduce the number of HGVs entering the village, but it is confused and contradicts itself across the various documents. There is no account of the hundreds of light goods vehicles which will clog up

all our lanes and access

I believe Rampion will substantially increase the destruction plan of more and more hedge and tree removal most of it in the Kent Street area .

How much of the first kilometre of Kent Street heading south from the A272 will have its hedges and trees stripped out for access points to the cable route?

How will enormous HGV,s turn in and out of Kent Street

I believe that the visibility plan for Kent Street and the new access to the substation will be almost continuous, with the loss of hundreds of metres of hedge.

Surly all of this makes it virtually impossible to hide the substation from view. The route in to Cowfold will be utterly changed, and Kent Street will form part of an industrialised landscape

The ecology at Cratemans, the green lane, Kent Street and Oakendene will be destroyed . What do Rampion do to prevent this?

Lack of engagement with landowners:

I live at a grade 2 listed building and have had virtually NO engagement with Rampion as to what affect the traffic, verge destruction, noise and air pollution will have on my house?

I can also confirm that the value of my house has more than halved since Rampion 2 was announced and is proving not saleable even at this level

The economy: local businesses will suffer significantly if they are unable to provide good access to their customers due to the chaos on the A272

Alternatives:

there has been very little meaningful consultation with the local community and as a result the plans being proposed by Rampion are half baked and not fit for purpose

and a result our communities around the Kent Street area will be devastated

for many years to come. this just CANT be right!

The local area with many listed buildings and residential communities quietly and peacefully enjoying our lives will become a noisy, destruction of our community in the short term and a heavily polluted area turned into a semi-industrial landscape in the longer term devastate the wildlife.
