STATUS

The Applicant has engaged with the Landowner since 2022, and through meeting and regular correspondence with the Landowner, the Applicant has outlined the Project to the Landowner and discussed the impact of the Project on the Property.

The Applicant has been able to provide re-assurance to the Landowner in relation to concerns relating to a pond and protection of trees, including adding bespoke terms into the Heads of Terms to facilitate the successful negotiations of the Heads of Terms, demonstrating meaningful consultation and engagement.

The Applicant issued Heads of Terms to the Landowner in April 2023, and the Heads of Terms were returned signed in May 2024.

NEGOTIATIONS FOR VOLUNTARY ACQUISITION OF RIGHTS

- Heads of Terms were issued in April 2023 further to a site meeting in March 2023
- Emails were sent in May 2023 explaining the Heads of Terms
- Further discussions regarding the Heads of Terms were picked up in early 2024 and clarifications added into the documentation by the Applicant
- The Landowner returned signed Heads of Terms in May 2024.

PROGRESS OF ENGAGEMENT FOLLOWING CAH1

- The Applicant has requested the Landowner to provide details of their solicitors.
- The Applicant sent an email dated 26th June 2024 issuing an increased easement consideration offer to ensure
 consistency with offers to other landowners.

LANDOWNER ENGAGEMENT (2022 to 2024)

- The Applicant has had detailed dialogue with the Landowner commencing from June 2022.
- Written correspondence issued both via emails and letters have been issued to the Landowners across this period as evidenced by the Landowner Engagement Tracker (below).
- The Applicant met with the Landowner in June 2022 and outlined the proposed Project and discussed the impact of the Project on the landholding. The Landowner raised a concern about circa 3,000 trees that had been planted along the A24. The Applicant was able to confirm that the A24 (and the trees) will have cables installed using Horizontal Directional Drilled (HDD) underground tunnel and that the cables are therefore unlikely to have any impact on the trees.
- The Applicant issued **Heads of Terms** to the Landowner in **April 2023**.
- The Landowner sought assurances from the Applicant over the impact of the cables on a pond and the trees. The Applicant provided assurances through including bespoke clauses in the **Heads of Terms**.
- The Landowner returned the signed Heads of Terms in May 2024.

 The cable route passes under the Landowner's holding – and through the use of an HDD crossing underneath the A24 and Washington Recreation Ground there will be minimal impact on the Landowner's landholding.
