STATUS

The Applicant has consulted with the Landowner since June 2021. The Landowner owns pasture land which is affected by the proposed onshore connection works (Plot 34/17) as well as rights of access over Wineham Lane (Plot 34/5 & 34/6). The proposed construction methodology in this location is Horizontal Directional Drilling (HDD).

Site meetings were held in November 2021 and October 2022 where the Applicant outlined the project's proposals, and addressed the Landowner's concerns surrounding project timescales.

Heads of Terms were issued on the 6 June 2024 and revised Heads of Terms on 25 June 2024. A teams meeting was held with the Landowner on the 26 July 2024 to agree the Heads of Terms which were received by email following the meeting.

NEGOTIATIONS FOR VOLUNTARY ACQUISITION OF RIGHTS

- The Applicant has met with the land interest on a number of occasions to outline the impact of the project on her landholdings.
- Following design changes and the confirmation of the substation site, it was communicated to the land
 interest by letter on 13 July 2022 that her land would be impacted by the proposed cable route.
- Heads of Terms were issued on the 25 June 2024.
- The Applicant contacted the Landowner via telephone on the **8 July 2024** and the Landowner confirmed they had no objection to the rights being sought from them or the project.
- The Applicant has received signed terms on the 26 July 2024.

PROGRESS OF NEGOTIATIONS TO ACQUIRE LAND RIGHTS FOLLOWING CAH 1

- Heads of Terms were issued on the 6 June 2024.
- Revised Heads of Terms were issued on the 25 June 2024.
- A Letter was sent on 8 July 2024 to confirm the project's position in relation to fees for professional advice.
- The Applicant made contact with the Landowner on the 8 July 2024 who confirmed they had no objection to the project or rights being sort from them.
- The Applicant will arrange instruct their solicitors to issue the draft Option and Easement once the Landowner has confirmed who they have appointed as their solicitor.

LANDOWNER ENGAGEMENT (2021 to 2024)

- The Applicant has been in correspondence with the Landowner since June 2021.
- Meetings were held in November 2021 (on a Teams call) and October 2022 (in person on site), where the
 Applicant outlined the project's proposals, and the Applicant addressed the Landowner's concerns
 surrounding project timescales.

IMPACT ON LAND INTEREST

- The Landowner owns pasture land affected by the proposed Rampion 2 cable route.
- The proposed construction methodology in this location is HDD.

IMPLICATIONS OF IMPACT

• The proposed construction methodology is HDD and there is no anticipated impact above ground in this location.

PROPOSED MITIGATION

- No anticipated above ground impacts as a result of HDD.
- Noise surveys to be arranged adjacent to the proposed HDD pit where sensitive receptors are identified.

OUTSTANDING ISSUES DELAYING CONCLUSION OF VOLUNTARY AGREEMENT

• The Applicant has received signed Heads of Terms from the land interest.
