In addition, we noted in our letter of 13 November that the Applicant continued to engage with Aquind Limited regarding the interface of the construction phases of the Rampion 2 Offshore Wind Farm and Aquind Interconnector. Aquind Limited has subsequently submitted further representations to the Secretary of State in relation to the Rampion 2 proposals. We are currently considering those submissions and will address their content when providing the Applicant's responses to Part 2 of the Request for Information contained in your letter of 25 November 2024.

Finally, for completeness we note that in the draft Development Consent Order submitted at deadline 6 **[REP6-007]** requirement 25 in Part 3 of Schedule 1 refers to chapter 25 of the environmental statement; this should be corrected to refer to chapter 24, which deals with ground conditions and risks of contamination.

We will write further in due course to provide the Applicant's responses to Part 2 of the Request for Information contained in your letter of 25 November 2024 which are due by 23:59 on 13 December 2024.
