	1000-1100	BESS and Longfield Substation	Drive on the internal site tracks from Stocks Cottage/farm, through to the north of Porters Wood/Toppinghoehall Wood. From there walk to BESS location - point 1 on the itinerary proposed by the Applicant at Deadline 1B. Walk around location, and then head back onsite internal tracks up to stocks and turn right onto Boreham/Waltham Road.
