 Page 69, Part 2 Conditions, Condition 12 refers to Maintenance of the authorised development, whereas the dDCO uses Condition 13 for this heading. See discrepancies in other headings in Conditions 13 to 34 inclusive. The condition numbers provided in the Explanatory Memorandum [APP-006] relate to the conditions at Part 2 of Schedule 8, which is the first deemed marine licence provided for in the draft DCO, and those at Schedule 10. In response to this section 51 advice, the Applicant has updated the Explanatory Memorandum to provide for the condition numbers used in Schedule 9 at paragraph 5.4.9, which is submitted alongside this response.

Book of Reference (Doc 6.3)

Para 2.1.7 refers to Article 27 rather than 32.

- Para 4.1.1 refers to Article 20 rather than 24.
- Para 4.1.1 refers to Schedule 7 however the title does not match the dDCO.

 Paragraph 10.33 refers to Article 31,rather than Article 33.

The Applicant has updated the Statement of Reasons in response to this section 51 advice, which is submitted alongside this response.

Land Plans (Doc 5.3)

- The naming of land plots in the Land Plans legends differs to that in the dDCO, for example:
 - The 'Land Subject to Acquisition of Rights' shown coloured blue on Land Plans is titled in Schedule 5 of the dDCO as 'Land in which only New Rights etc. may be required'.
- The 'Land Subject to Freehold Acquisition' is shown in pink on the Land Plans, but these do not appear to be mentioned in the dDCO.

Applicant's Response

The Applicant considers the naming of land plots on the Land Plans to be sufficiently clear and to accord with precedent. As such, no change is proposed.

The Land Subject to Freehold Acquisition is the land referred to in article 21 of the draft DCO. The Applicant considers its approach to be sufficiently clear and to accord with precedent. As such, no change is proposed.

Polygon 13-029 on Sheet 13 was incorrectly included under 'Land Subject

- On Sheet 13, plot number 13-029 is included in the Legend under both 'Land Subject to Acquisition of Rights', and 'Land Subject to Freehold Acquisition'. The polygon is coloured pink on the Sheet.
- On Sheet 13 in the inset box to the left of the Sheet, the labels are 13-026 and 13-027 and 13-041, do not appear to match other numbering on that sheet.

The inset box referred to has been corrected to show the relevant plots, being 13-027, 13-028 and 13-046.

Public Rights of Way (Doc 5.11), Access to Works Plan (Doc 5.9) and dDCO (Doc 6.1)

- Little Bromley FP15 is stated in the dDCO as being on Sheet 18 of the public rights of way plan but it is on Sheet 15 & 16.
- Little Bromley FP16 is stated in the dDCO as being on Sheet 17 of the public rights of way plan but it is on Sheet 15.
- On the Access to Works Plan Church Lane is mentioned in the dDCO but on the plan it is only labelled at its marked point (OA-1)
- On the Access to Works Plan Pork Lane is mentioned in the dDCO but on the plan it is only labelled at marked points (OA-6 & OA-7)

Applicant's Response

The Applicant has updated the draft DCO and added the references to Church Lane and Pork Lane on the Access to Works Plan, in response to this Section 51 Advice, which is submitted alongside this response.

Consultation Report (Doc 4.1)

- Appendices:
 - There is no Appendix A, therefore it starts at B.
 - There are numbers missing eg there is no c.14 and no D.12.
 - They are not referred to in the Consultation Report though it

Appendices

 Point 1: When developing the Consultation Report's referencing convention, the Applicant reserved Appendix A for any appendix items that may have been needed for the Consultation Report's introductory summary. As the Consultation Report

- is not clear why the numbering is not consistent.
- The names of a NHS foundation trusts have changed. North Essex Partnership NHS Foundation Trust listed as a consultee Appendix F (F.22) is now NHS Suffolk and North East Essex Integrated Care Board.
- It is noted that:
 - Page 29, box 52 refers to Appendix 10.1, rather than 10.1.1.
 - Page 75, table 6.4 refers to Appendix F.19 and F.11.1 which are missing. Section 55 Acceptance of Application Checklist – North Falls Offshore Wind Farm 26 of 30
 - Page 67, table 5.3 refers to Appendix E21.1 which is missing.
 - Page 64, table 5.1 refers to Appendix E.4 which is missing.

- developed no such appendix items emerged, and so Appendix A remained empty.
- o Point 2: While drafting the Consultation Report the Applicant identified some items within the referencing convention that were no longer required or were already referenced elsewhere within the Consultation Report and therefore The duplicated. Applicant removed such references from the Consultation Report's appendices rather than restructuring referencing convention.
- The Applicant can confirm that no appendix items are missing. For instance, Appendix C.14 was removed ahead of submission as it was a duplication of Appendix G.15. Appendix D.12 was removed ahead of submission as it showed the Applicant's red line boundary, which is already shown in other appendix items.
- Point 3: See point 2.

1.1.1 The Applicant has updated Appendix F.22 within Appendix F.15 to F.30 Part 3 [APP-233], which has been resubmitted alongside this response. Given the significant size of appendix documents and Microsoft Word's design limitations, all appendix documents have been created in Adobe InDesign and so a track changed version cannot be submitted. Board' can be found on page 886 of the resubmitted appendix.

Page 29, box 52

 In the updated Consultation Report submitted alongside this response, reference to Appendix 10.1 has been changed to Appendix C.10.1.

Page 75, table 6.4

1.1.2 In the updated Consultation Report submitted alongside this response, reference to Appendix F.19 and Appendix F.11.1 have been removed. The Applicant decided while drafting the Report that Consultation Appendix F.19 was not required and that an online version of what was going to be Appendix (PEIR Non-Technical F.11.1 Summary) should be linked to rather than appended.
