Drax Power Station Bioenergy with Carbon Capture and Storage

- 1. We write on behalf of Drax Power Limited ('the Applicant') to provide the Proposed Changes Application, with reference to the above and following the receipt of the Examining Authority's ('ExA') responses, dated 23 September 2022 and 10 October 2022 ('the ExA's letters'), to the Applicant's Change Request letter and follow-up correspondence dated 12 September 2022 and 30 September 2022. The Proposed Changes Application responds fully to the points made in the ExA's letters and is intended to contain sufficient information to enable the ExA to consider two proposed minor changes to the application for development consent for the Drax Bioenergy with Carbon Capture and Storage ('BECCS') ('the Proposed Scheme') project ('the Application') or to prepare further questions, if necessary.
- 2. Proposed Change 01 (PC-01): The Application submitted to the Planning Inspectorate committed to providing floodplain compensation as part of the Proposed Scheme but did not confirm where this was to be located. Since the Application was submitted, the Applicant has been able to investigate solutions to the floodplain compensation and has continued to engage with Interested Parties such as the Environment Agency to confirm a suitable solution. This solution comprises land within the Applicant's ownership, but not previously included within the Order Limits. Further details of PC-01 are set out under Sections 2 and 5 of the submitted Proposed Changes Application Report (PCAR) (Doc. Ref. 8.5.1).

- 3. Proposed Change 02 (PC-02): Relocation of existing overhead lines in respect of two electrical lines and two telecommunications lines which cross the access route to the Site at A614 (Rawcliffe Road) and the A645 to allow for the delivery of Abnormal Indivisible Loads (AILs) to the Site. Further details of PC-02 are set out under Sections 2 and 6 of the PCAR (Doc. Ref. 8.5.1). This Proposed Change involves land that is outside of the current Order Limits, is not in the ownership of the Applicant and over which it is proposed to compulsorily acquire rights ('the CA Additional Land'). As such, the Infrastructure Planning (Compulsory Acquisition) Regulations 2010 ('the CA Regulations') are invoked.
- Consequently, some of the documents submitted alongside the Proposed Changes Application also constitute documents required under Regulation 5 of the CA Regulations. Where this is the case, this is noted below.
- 5. Accordingly, we submit the following documents for consideration as part of the Proposed Changes Application:
