#### Drax Power Station Bioenergy with Carbon Capture and Storage

- 1. We write on behalf of Drax Power Limited ('the Applicant') with reference to the Proposed Changes Application submitted by the Applicant on 5 December 2022. The submitted Proposed Changes Application Report (AS-045) sets out the full scope of the proposed changes and the assessment thereof.

		The Applicant has noted the following query in the Letter: Should centre lines be shown for Work No. 8 on the Works Plans given it relates to overhead lines?	
		The Applicant response is that the overhead lines for Work No. 8 are not shown on the OS Master Mapping, which is considered likely due to these being low voltage. Inclusion of the overhead lines would therefore need to be undertaken manually by hand which is considered inappropriate for statutory plans. Additionally, the Works involve a combination of removing parts of a line; restringing and moving existing poles and lines; and undergrounding parts of a line within that area, so there is not one 'centre line' to be applied within the Works areas.
