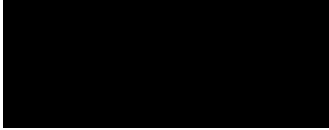
4. An updated clean version of document 6.5, the Register of Environmental Actions and Commitments, has been submitted at Deadline 1 to correct an omission of an appendix

from the previous version at AS-092. The updated version now includes Appendix A - CEMP Watercourse Pollution Prevention Plan.

5. There is no update to the previously submitted version of the Statement of Common Ground with Historic England, and thus the most up to date and signed version of this document is already within the Examination Library at AS-033.
6. A new Statement of Common Ground (SoCG) is being prepared and discussed between Airmyn & Goole Area IDB and Drax Power Limited. The Applicant will update this draft document to take account of responses from this party after the close of the Relevant Representations on 12th February 2023, and intends to submit a draft version of this SoCG to the ExA at Deadline 2.
7. Document 8.6.1 provides a draft itinerary for the Accompanied Site Inspection, including viewpoints and a plan of the route. This document also includes the security protocol which sets out the security requirements as per the discussion at the Preliminary Meeting.
8. Responses to all Action Points raised by the ExA following the Hearings held on 18th and 19th January 2023 are provided in document references 8.6.2 and 8.6.3 which provide the Applicant's post-Hearing submissions. In this regard, it is noted that an Addendum to the Planning Statement is being prepared to provide an update on relevant planning policy matters which will be submitted in response to the ExA's first set of Written Questions at Deadline 2.
9. With respect to the draft section 106 agreement submitted at this Deadline 1, following comments made by the ExA at Issue Specific Hearing 2, and in agreement with Selby District Council and North Yorkshire County Council, the obligations relating to a community liaison group have been removed and will instead be secured via a requirement in the draft development consent order to be submitted at Deadline 2. The parties are discussing whether the same approach can be adopted with respect to the local employment plan, and the Applicant hopes to confirm this at Deadline 2 (and provide any consequential updates to the draft development consent order at that time).
10. With respect to the National Policy Statement Tracker document reference 8.8 submitted at this Deadline, this first version largely replicates the content of the Planning Statement, and therefore, in addition to the requested 'clean' version, we submit a tracked version, in order to show updates from the original submission.
11. Enclosed with this letter are the above documents via the file upload facility on the project application website¹, as agreed with the Inspectorate via the Rule 6 letter on 13 December 2022.
